## National Health Care Fraud Enforcement Action Results In 193 Defendants Charged And Over \$2.75 Billion In False Claims

Six Defendants Charged in the Eastern District of Tennessee

U.S. Attorney Francis M. Hamilton III announced criminal charges against six defendants in connection with alleged schemes to defraud the U.S. Department of Labor, Office of Worker's Compensation Program, Division of Energy Employees Occupational Illness Compensation ("DOL-DEEOIC").

The charges filed in federal court are part of the Justice Department's 2024 National Health Care Fraud Enforcement Action. The charges stem from the submission, or causing the submission, of fraudulent claims for home health services that were not actually rendered.

The charges announced today by U.S. Attorney Hamilton are part of a strategically coordinated, two-week nationwide law en-

forcement action that resulted in criminal charges against 193 defendants for their alleged participation in health care fraud and opioid abuse schemes that, in the aggregate, resulted in the submission of over \$2.75 billion in alleged false billings.

The DOJ Health Care Fraud Unit's National Rapid Re-

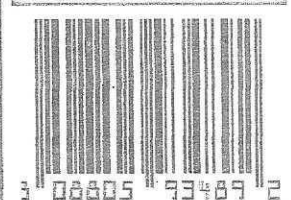

### Charged

Bryan Cummings, 35, Highway 72 Loudon, was charged with Man/Sell/Del/Resale Sch. I, and Mfg/Del/Sale or Poss. of Meth, and Poss. of Drug Para.

Justin Hackler, 30, Wade Road Loudon, was charged with Driving on Revoked/Suspended License.

Deputy Harrison LCSO, observed a gold Cadillac sedan traveling on East Sixth Avenue fail to stop before the white-painted stop bar at the red light at East Sixth Avenue and Kingston Street. Deputy Harrison conducted a traffic stop on the vehicle on Kingston Street at East Third Avenue. Upon contact with the driver, Justin Hackler, and front seat passenger, Bryan Cummings, Hackler stated he did not have a valid license. At this point,

Deputy Harrison had Hackler step out of the vehicle and Cummings step out and stand on the passenger side. While conducting a consent search of Hackler due to him having multiple concealed knives, Deputy Harrison could smell the odor of marijuana emitting from his person. Inv. Green observed Cummings attempting to conceal items within his right front pants pocket while my attention was on the driver. Once Inv. Green made contact with Cummings he could smell the odor of marijuana emitting from his person. During a probable cause search of Cummings., Inv. Green located 3 baggies in the front right pants pocket he was attempting to conceal contraband in. One baggie contained approximately 0.25g of a brown powder substance testing positive for meth/fentanyl com-

pound, another containing .21g of a crystal substance testing positive for meth, and .17g of marijuana. Both subjects were detained and Deputy Harrison deployed his K9 partner Draco to sniff the free air around the vehicle, at which point Draco positively alerted to the passenger front door. During a probable cause search, Deputies located a black case inside a

backpack on the floorboard of the front passenger seat containing two meth pipes with residue, and a scale with residue. Loudon County Dispatch advised Hackler's license to be revoked during the search and at this point both subjects were placed in custody. Money makers arrived and impounded the vehicle. This did occur in Loudon County, Tennessee.

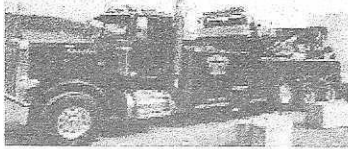

Rosie Boston, 39, Donaldson Road Philadelphia, was charged with Mfg/Del/Sale or Poss. of Meth, Driving on Revoked/Suspended License, Financial Responsibility Law, and Signing Registration in Vehicle.

Deputy Reagan 987, observed a white Mercedes with pink Greek lettering on the back window pass deputy Reagan on Roberson Springs Rd. Deputy Reagan observed a female driving the vehicle. Deputy Reagan recognized the vehicle and the female from past incidents, and he remembered that the female

had a suspended license. Deputy Reagan then turned around and caught up to the vehicle. Dispatch confirmed that the registered owner, Rosie Boston (Arrestee), has a suspended license. Deputy Reagan activated his emergency equipment and conducted a traffic stop at Pond Creek Rd and McCrary St. Upon approach, the deputy confirmed the female driving to be Rosie Boston. She immediately became agitated and passively uncooperative. Boston stated that she did not have the insurance or registration information for the vehicle. She also stat-

ed that she knew her license was suspended. The deputy asked Boston to exit the vehicle, which she did. She was hesitant to step away from the driver's side door. The deputy asked her to call someone to get the vehicle, which she did. At that time, the deputy placed her in custody and began a search of her person. She then became agitated again and requested a female officer to search her. Officer Ingram responded and assisted with searching her. Deputy Reagan asked Boston if there was anything inside the vehicle and if he had her consent to search the vehicle. She was uncooperative and would not give a definite answer to either question. At that time, Narcotics Investigators Green and Grey responded on scene. Investigator Grey deployed his partner, K9 Kora, and she immediately alerted to the odor of narcotics at the front of the vehicle. During a probable cause search of the vehicle, deputy Reagan located a folded piece of paper on the driver's seat. Upon opening the paper, the deputy discovered a white crystal-like substance believed to be methamphetamine. At that time, the vehicle was turned over to a friend, and deputy Reagan transported her to the Loudon County Jail. The suspected methamphetamine was tested and weighed by Narcotics Investigator Grey, and was confirmed to be meth and weighed 0.5g. This did happen in Loudon County, TN.

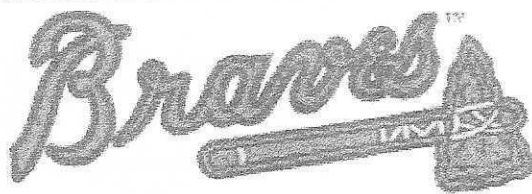

Bryson Whitt, 20, Homeless Loudon, was charged with Public Intoxication, Resisting Arrest, Criminal Trespassing, and Assault.

Officer Robinson LCPD, received a phone call from off duty officer Z. Parmer stating that he had received a phone call from Braden Shelton who was at Sonic and observed a male "yelling at customers, nodding out, and cussing". Officer Robinson went to Sonic to attempt to make contact with Bryson Whitt. Upon arrival he made contact with Mr. Whitt who was standing in the middle part of Sonic at the tables yelling at customers and calling them "bitches". Officer Robinson advised Mr. Whitt to have a seat on one of the benches to which he did and asked him if he had taken any illegal narcotics to which he stated no. Mr. Whitt's pupils were pinpoint and he was be-

ing aggressive with other patrons at the restaurant along with himself. Mr. Whitt then stated that he was on probation for simple possession of Marijuana. LT. C. Butler then arrived on scene, and Robinson stated to him that he believed he was under the influence of narcotics, to which he agreed. Robinson asked Mr. Whitt to stand up and place his hands behind his back, Mr. Whitt stood up and attempted to sprint away from LT. Butler and Robinson to which he was tackled approximately six feet away from where he started to run. Robinson turned his department issued taser on and placed it in the middle of his back to gain compliance from him but never had to discharge a probe or a drive stun. One of the witnesses, assisted them in placing him into custody using soft hand techniques along with LT. Butler. Mr. Whitt start-

ed complaining about neck pain, so officers had EMS come to the scene and check him out. Upon their arrival they opened the back of his patrol car and Mr. Whitt stated he was fine and did not need any treatment. Mr. Whitt also had two General

Sessions warrants issued by Loudon Police Department. One was for assault and another for criminal trespass. Mr. Whitt was then transported to the Loudon County Jail without further incident. All the above did occur in Loudon County, Tennessee

Texas, Southern District of Texas, Eastern District of Virginia, Western District of Virginia, Southern District of West Virginia, and Eastern District of Wisconsin; and State Attorney Generals' Offices for Arizona, California, Illinois, Indiana, Louisiana, New York, Oklahoma, Pennsylvania, Puerto Rico, Rhode Island, and South Dakota are prosecuting the cases in the National Enforcement Action, with assistance from the Health Care Fraud Unit's Data Analytics Team. Descriptions of each case involved in today's enforcement action are available on the Department's website at Case Descriptions.

The U.S. Attorney's Office for the Eastern District of Tennessee, in particular, worked with the Federal Bureau of Investigation, the Department of Labor - Office of Inspector General, and the Tennessee Medicaid Fraud Control Unit.

In the United States District Court for the Eastern

District of Tennessee, Caleb Mullins, 40, Megan Mullins, 37, both of Oak Ridge, Tennessee, and CAMM Care, LLC doing business as Patriot Homecare ("CAMM Care"), were charged by indictment in connection with an alleged scheme to defraud the DOL-DEEOIC. DOL-DEEOIC administers the health care benefit program designed to compensate current or former Department of Energy employees, vendors, contractors, and subcontractors diagnosed with occupational illnesses causally linked to toxic exposures during their employment. Among other health care benefits, this program provides home health benefits to qualifying beneficiaries, including skilled nursing care and non-skilled care. As alleged in the indictment, Caleb Mullins, the owner and President of CAMM Care, and Megan Mullins, the Executive Vice President of CAMM Care, conspired with each other and others

not named in the indictment to create and submit fraudulent payment claims for homecare services that were not actually rendered.

Samantha Seiber ("Seiber"), 35, of Wartburg, Tennessee, Apryl Hard ("Hard"), 46, of Louisville, Tennessee, and Lois Hamby ("Hamby"), 62, of Oliver Springs, Tennessee, were also charged in separate indictments with defrauding the DOL-DEEOIC. As alleged in the respective indictments, Seiber, Hard, and Hamby each had her own DOL-DEEOIC provider number, and each billed the DOL-DEEOIC for skilled nursing services that were not actually rendered.

The cases in the Eastern District of Tennessee are being prosecuted by Assistant United States Attorneys William A. Roach, Jr., and Jeremy S. Dykes of the United States Attorney's Office for the Eastern District of Tennessee.
