## Evelyn Blevins Sentenced to 51 Months in Prison for COVID-19 Unemployment Insurance Fraud Scheme

Evelyn Blevins, 48, of South Pittsburg, Tennessee, was sentenced to 51 months' imprisonment by the Honorable Curtis L. Collier, United States District Judge in the United States District Court for the Eastern District of Tennessee at Chattanooga. Following her incarceration, she will be on 5 years of supervised release.

As part of the plea agreement filed with

the court, Blevins pled guilty to Wire Fraud and Aggravated Identity Theft, in violation of Title 18, U.S.C. §§ 1343 and 1028A, for her involvement in a scheme to defraud COVID-19 unemployment programs in several states. In addition, Blevins was ordered to pay \$109,683 in restitution to the Tennessee and California Departments of Labor, and to forfeit to the United States \$109,683 as part of a money judgment.

According to court documents, from June 2020 through August 2021, Blevins conspired with others to devise a scheme in which she defrauded the United States government and the governments of Tennessee, Alabama, Pennsylvania, and California to obtain money from the states' COVID relief programs in the form of unemploy-

Fred Ledford, 45, Acorn Gap Road Madisonville, was charged with, Man/Sell/Del/Resale Sch. II.

Cpl. L. Hawkins LCSO, was dispatched to a wreck on Highway 444 at Mile Marker 10.5. Deputy Hawkins arrived on the scene and observed a Green Honda Accord off the roadway in the tree line.

When the deputy approached he noticed there was no vehicle damage and the driver, Fred Ledford, was still on the scene.

When the deputy began talking to him he was fidgeting with his left pants pocket. The deputy instructed him to remove his hands from his pocket. Directly after he placed his right hand into his pocket and his left hand on his hip. The deputy then conducted a pat down search for his safety. Through the exterior of his pants the deputy felt what he immediately knew was a pill bottle.

The deputy asked Mr. Ledford for consent to search the interior of his pockets and he consented.

Inside the front left pants pocket he found a cigarette pack. Inside the pack was a small clear bag. Inside the bag was a clear substance that appeared to be meth.

The deputy then placed Mr. Ledford into custody. When he was asked about the meth he denied ownership stating that he found it inside his vehicle and that it had been left there by another subject. Money-making

Wrecker Service arrived on the scene and towed the vehicle. The deputy then transported Mr. Ledford to The Loudon County Jail. When the deputy arrived at the Jail he took the substance to Lt. S. Ezell to be tested by TruNarc.

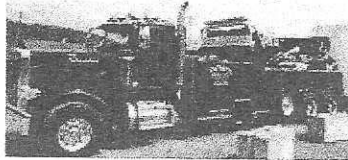
The substance tested positive for Methamphetamine via TruNarc scan #2685.

Michael Nixon, 31, Fairlane Road Florida, was charged with Domestic Assault.

Officer Cole LCPD, was dispatched to Kaley Lane in reference to a physical domestic. The calling party, identified as the victim, reported that her brother, Michael Nixon, had physically assaulted her during a verbal altercation. Upon arrival to the residence officers observed a distressed female within the curtilage and identified her as the victim. She informed officers that her brother had struck her in the face with a closed fist and that he was still believed to be within the residence. Officers conducted preliminary search of the residence to locate Mr. Nixon and clear for any additional threats. Upon clearing the residence, officers could not locate the suspect nor were there any

additional threats identified within the home. Furthermore, officers observed that Mr. Nixon had left numerous personal items behind, including a set of keys and his cellphone.

Due to the totality of the circumstances officers would maintain a presence within vicinity in further attempt to locate the suspect and sustain the peace. The victim filled out domestic violence statements and were informed of their legal rights and responsibilities. As officers were exiting the residence a male who fit the description of the suspect, Michael Nixon, was approaching the residence from the road.

The individual appeared visibly anxious and distressed, showing signs of nervousness and agitation. Mr. Nixon's demeanor was indicative of significant emotional distress, with noticeable signs such as rapid

breathing, trembling, and difficulty maintaining eye contact; officers observed this and placed Mr. Nixon into police custody. Michael Nixon was then informed he was being charged with

domestic assault in pursuant to Tennessee State Law and as a was transported to the Loudon County Jail without further incident.

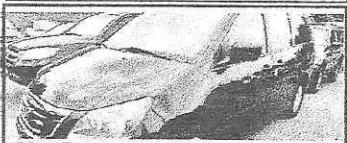

ment insurance proceeds funded by the United States government. Specifically, Blevins acquired personal information from others and used it to fraudulently make mass online applications for money earmarked by the states to provide unemployment insurance relief for those affected by the national pandemic. She falsely claimed in the applications that the individuals whose personal information was reflected on the applications worked in those states. The states then mailed debit cards to addresses in the Eastern District of Tennessee, and Blevins would receive a percentage of the payout of the fraudulent claim. The defendant was personally responsible for the fraudulent distribution of nearly \$110,000 of unemployment protection insurance funds. The scheme itself involved the fraudulent distribution of over \$550,000 in unemployment protection insurance funds.

“The defendant selfishly sought to take advantage of federal and state efforts to provide relief to those most harmed by the COVID pandemic,” said United States Attorney Francis M. Hamilton, III. “We remain committed to partnering with all law enforcement agencies to identify and prosecute those who steal from federal relief plan programs, depriving others who are most in need.”

“The defendant’s actions cheated a program designed to assist people who were suffering as a result of the COVID pandemic,” said FBI Special Agent in Charge, Joseph E. Carrico. “Today’s sentencing exemplifies the continued commitment of the FBI and our federal and state law enforcement partners to hold those who engage in COVID relief fraud accountable for their actions.”

Assistant United States Attorney Steven Neff represented the United States.

The investigation was con-

ducted by the Department of Labor Office of Inspector General and the FBI as part of the Smoky Mountains Financial Crimes Task Force.

On May 17, 2021, the Attorney General established the COVID-19 Fraud Enforcement Task Force to marshal the resources of the Department of Justice in partnership with agencies across government to enhance efforts to combat and prevent pandemic-related fraud. The Task Force bolsters efforts to investigate and prosecute the most culpable domestic and international criminal actors and assists agencies tasked with administering relief programs to prevent fraud by, among other methods, augmenting and in-

corporating existing coordination mechanisms, identifying resources and techniques to uncover fraudulent actors and their schemes, and sharing and harnessing information and insights gained from prior enforcement efforts. 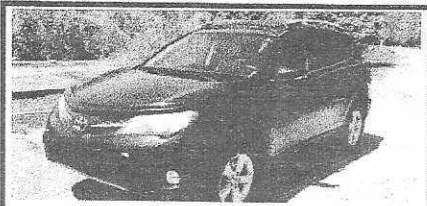

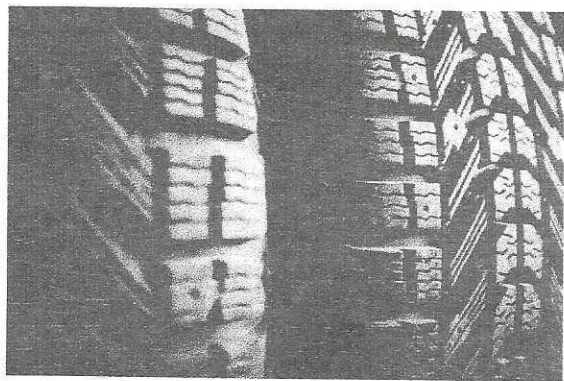

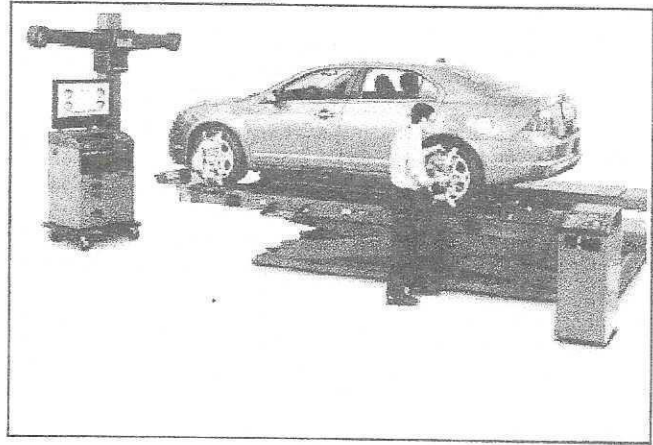
