The FBI Victim Services Division (VSD) FBI Victim Outreach Support and Strategy (VOSS) Team

The VOSS team develops and implements strategies to communicate key notifications and resources to victims of crimes investigated by the FBI and to offer opportunities for victims to voice their experiences to law

enforcement.

Each year, the FBI investigates thousands of crimes involving hundreds of thousands of victims.

Our Victim Services Division (VSD) informs and assists victims navigating the aftermath of crime and the criminal justice process. One piece of that mission involves coordinated outreach to victims to support their needs, a special-

ty that falls under the FBI Victim Outreach Support and Strategy (VOSS) Program.

Established in 2017, the VOSS team specializes in outreach in cases with 150 or more victims. They have worked on cases including the Boston Marathon; the Lewiston, Maine, mass shooting; and the

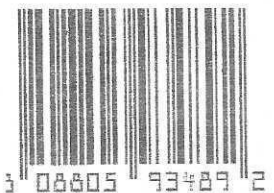

The report stated, Officers initiated a traffic stop on the vehicle at the entrance of Loves and it did not stop until it was on the I40 East bound ramp. While the vehicle was still moving officers observed heavy movement from the three occupants. While approaching the vehicle officers also observed a syringe in Mr. Howards lap and a scale and narcan in the center console. Officers detained the three occupants of the vehicle Samantha Bailen, Corey Howard, and Kenneth Hyso due to there being a knife.

After talking to the three individuals' officers were granted consent to search the vehicle. During the search officers located

small baggies with residue, a white crystal-like substance, a gray powdery substance, two needles with a brown colored liquid, two spoons one being broken on the end and the other having two small pieces of cotton in it, a green leafy substance inside of a small black container, and a scale. None of the individuals admitted ownership of the narcotics and were all placed into custody.

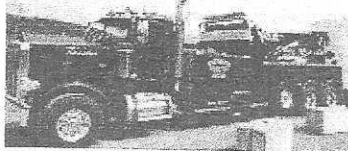
All parties had a Suspended License status. The vehicle also did not have insurance and was towed from the scene to Money-makers. All parties were transported to the Loudon County Jail without further incident.

Michael Ball, 36, Burnette Lane Oneida, was charged with Domestic Assault, and Public Intoxication.

Sergeant A. Lee LCPD, was dispatched to Jim Hartsook Drive, Apartment G2, in reference to domestic assault.

Upon arrival Sgt. Lee made contact with Michael Ball in the parking lot of the complex. Ball showed several indicators of impairment including slurred speech, unsteady stance, watery eyes, and the odor of an alcoholic beverage emitting about his breath and person. Ball admitted to consuming alcoholic beverages. For his safety and the safety of all others Ball was detained and secured in his patrol vehicle for the duration of the investigation. Ball states he was with the victim but decided to leave due to her becoming belligerent from excessive alcohol consumption. Ball denies stealing victims cell phone or dragging her with his vehicle. Sgt. Lee then spoke with the victim, at her apartment. Sgt. Lee immediately observed multiple

lacerations on her head, face, arms, hands, legs, and feet. The victim was reluctant to tell officers how she sustained the aforementioned injuries, initially stating she fell down the steps inside her apartment. Eventually the victim admitted that Ball and her were arguing due to "trust issues". Ball took victims cell phone and attempted to leave. The victim states she tried to stop Ball from leaving with her phone when he accelerated resulting in the victim being dragged by the vehicle. The victim advised officers she doesn't want to pursue charges against Ball in reference to the stolen cell phone. Officers were unable to locate the victim phone on scene. Officers did locate and photograph, utilizing Axon Capture, puddles of blood in the parking lot from the incident.

The victim refused medical attention. Due to all the above Michael Ball was placed under arrest and transported to the Loudon County Jail without further incident. Said incident did take place within Loudon County, TN.

Amber Harman, 39, Homeless Loudon, was charged with Public Intoxication, Criminal Impersonation, and Possession of Drug Para.

Deputy Frye LCSO, was approached by the complaint/victim in the Love's Travel Center Parking Lot (9155 US-321). The victim stated that a female in his van had told him she was going to kill him. He stated he had picked up the female at Cracker Barrel in Crossville, and was going to take her somewhere. Deputy Frye spoke with the female, who advised she had come from Michigan and had met the victim in Crossville. Deputy Frye asked the female her name and she stated it was Amanda. The female advised the deputy that "she went off on him" when he attempted to use her debit card to pay for gas. While

speaking with the female, she displayed rapid speech, excessive sweating, and was saying things that did not make sense. The female was also incredibly agitated when speaking with Frye and Deputy Parks. Deputy Frye and Deputy Parks entered Loves and spoke with the clerk about the use of the females debit card. The clerk advised the victim had not paid for gas and when he purchased coffee had paid for cash both times. When deputies exited the store, the victim advised there were narcotics in the vehicle, specifically stating two grams of meth.

The victim also advised the female had smoked crack while inside the van. Deputies on scene believed the female to be under the influence of an intoxicant due to her behavior as well as victims account. The van was owned and operated by the victim, who also gave

consent to search. Deputy Allen arrived on scene, and asked the female to step out of the vehicle. The female refused, and Deputy Allen assisted the female out of the car, where she was placed into custody. The vehicle was searched and yielded 3 meth pipes, a bottle of Jim Beam whiskey, as well as a snort straw. Deputies also located a Michigan ID for the female, identified as Ms. Amber Harman.

The evidence was seized and we returned to the vehicle to speak with Ms. Harman. Ms. Harman then advised that she had been raped by the victim, as well as that

she would like to go to the hospital for a mental evaluation due to having homicidal and suicidal ideations. CID responded to the scene and spoke with the victim, as well as obtained a Buccal swab. The victim stated the two had consensual sex at the Crossville Red Roof Inn. Ms. Harman was transported to the hospital for a mental eval as well as a rape analysis.

At the hospital, Ms. Harman advised the alleged rape happened in Crossville at the Red Roof Inn, and admitted to telling the victim she was going to kill him. She even stated she probably should have done it.

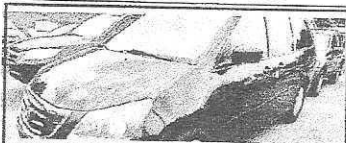

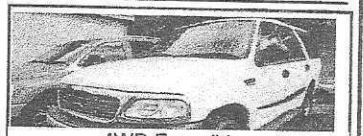

Most often, the VOSS team develops "Seeking Victim Information" questionnaires that can be valuable to the investigation and essential to receiving accurate victim contact information. Although they are not meant to supplement interviews, these questionnaires can narrow down a large victim pool to victims most affected by the crime, act as a line of communication to victim specialists, and offer an opportunity in real-time for the FBI to warn victims about ongoing crimes. The VOSS team also creates accompanying web pages with resources, case updates, and other victim-specific support information on fbi.gov. Any of these materials are translated into a foreign language as needed.

By the time most cases reach the VOSS desk, the

FBI investigative team may or may not know the specific population of people affected in a case. Cases where the victim population is unknown—called zero victim population cases—require the VOSS team to do a bit of their own detective work: They need to distribute calls for victims to come forward to be able to offer any services and support.

One case involved a school-teacher who had abused children over the span of 20 years in a specific town. Over time, those children may have moved to another city, state, or even another country. As they grew up, their names may have changed. Determining how to reach them in the present day is part of the VOSS team's work.

As the VOSS team strategizes the communications channels that are most likely to reach certain demographics, whether nationally

or internationally, they will tap partners across FBI divisions, other government agencies, and private organizations, such as the National Center for Missing and Exploited Children (NCMEC) and AARP, to help get the word out and publicize the questionnaires and resource pages. Tactics range from creating posts across social media platforms that potential victims may view to leveraging local and national news outlets.

What to Do if You're a Victim of Crime:

Submit an anonymous tip online

Report cyber scams and incidents

Contact your local FBI field office

Contact your nearest international office

Check the Seeking Victim Information pages to see if you've been affected by any of the cases

For instance, during a case that involved reaching out to an Amish community that did not use technology, VOSS worked with a local newspaper in Pennsylvania to translate seeking victim information into Pennsylvania Dutch, so it was accessible to the community.

"Our biggest asset that we have is our liaison partners," said Shannon.
