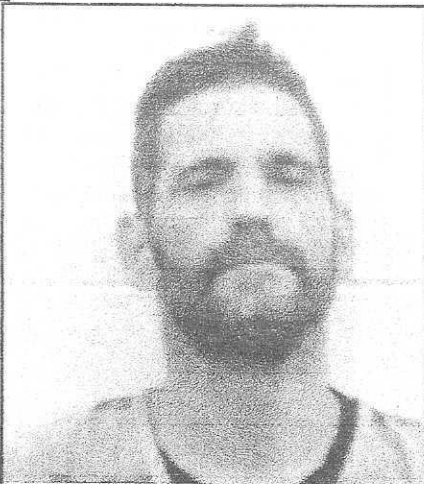

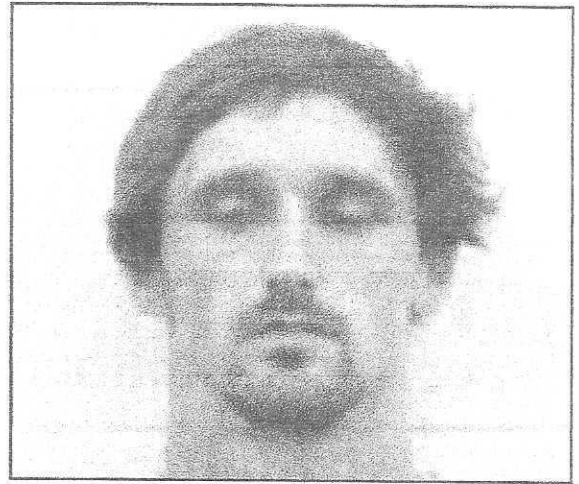

Knoxville Man Sentenced To 15 Years For Enticement Of A Child

Dominique J. Starr, 29, currently of Knoxville, Tennessee, was sentenced to 180 months imprisonment by the Honorable Thomas A. Varlan, United States District Judge, in the United States District Court for the Eastern District of Tennessee at Knoxville. Following his incarceration, Starr will be on supervised release for twenty years and will

be required to register with state sex offender registries and comply with special sex offender conditions during his supervised release.

As part of the plea agreement filed with the court, Starr agreed to plead guilty to an information charging him with one count of enticement of a child in violation of 18 U.S.C. § 2422(b).

According to documents filed with the

court, in October 2022, Starr began communicating online with a Federal Bureau of Investigation (FBI) undercover agent in Portland, Oregon, whom Starr believed to be a 13-year-old female. Starr solicited nude photos and sex from the purported minor on several occasions over a period of many months.

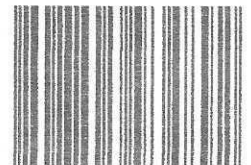

ban from Walmart, Mr. Clark was banned for life today. Both were placed into the back of patrol cars to be transported to the Loudon County Jail. While placing both into patrol cars officers noticed that their eyes were pinpoint, both were profusely sweating, and both were making very erratic movements. While Officer H. Wilkes was transporting Mr. Clark he admitted to being intoxicated on "heroin". Ms. Branum then advised she was as well. Both Clark and Branum were transported without any other incidents. All the above did occur in Loudon County, Tennessee

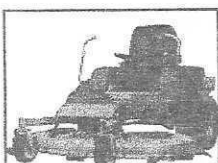
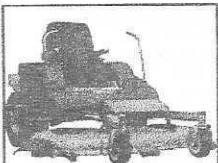
Officer Carroll LCPD, responded to the area of 9th Ave/Kingston St in reference to a Reckless Driver call that was coming into the city from the Justice Center. Once the officer arrived in the area, he observed the vehicle in question traveling W on 9th Ave, and turn S onto B street. While behind the vehicle, the officer observed the vehicle

leave the roadway, and travel into the yard of B St, and attempt to hide behind the residence. The officer was able to make contact with the driver, and the vehicle behind the residence. The driver was identified as Justin Plummer, and the vehicle was identified as a green Kawasaki dirt bike that was unregistered. Mr. Plummer had attempted to "flee" officers before the officer made contact with him behind the B street residence. Officer Eldridge observed Mr. Plummer on West Hills Dr, and initiated his department issued patrol vehicle lights, and sirens, but Mr. Plummer refused to stop. Officer Eldridge did not pursue Mr. Plummer due to the unsafe operations of Mr. Plummer's driving. Mr. Plummer was placed into custody, and officers were able to locate approximately 1.25g of a white, crystal-like substance believed to be Meth on his person, along with a meth pipe. The bike was towed to Money Maker's due to being unregistered, and having no insurance. The officer spoke to the owner of the dirt bike who was identified as the victim, who advised that Mr. Plummer was helping him move stuff out of his garage, and saw the dirt bike and had inquired about it. The victim advised that he gave consent for Mr. Plummer to work on the dirt bike, and try to fix it, but never gave Mr. Plummer consent to drive it. This incident did take place within Lenoir City, Loudon County, TN

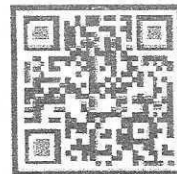

Starr

Starr also threatened to stalk, kidnap, and rape the purported minor. During the investigation, undercover agents from two other FBI offices reported contact with Starr after he solicited nude photos and discussed meeting them for sex. The FBI obtained search warrants for social media accounts associated with Starr which showed Starr was in contact with approximately 47 other purported minors ranging in age from 9 years old to 17 years old.

U.S. Attorney Francis M. Hamilton III of the Eastern District of Tennessee and FBI Special Agent in Charge Jo-

seph E. Carrico made the announcement.

The criminal information was the result of an investigation by the FBI. This investigation was led by FBI Special Agent Jason Stewart.

Assistant United States Attorney Jennifer Kolman represented the United States.

This case was brought as part of Project Safe Childhood (PSC), a nationwide initiative launched in May 2006, by the Department of Justice to combat the growing epidemic of child sexual exploitation and abuse. Led by the United States Attorney's Offices and the Criminal Division's Child Exploitation and Obscenity

Section, PSC marshals federal, state, and local resources to locate, apprehend, and prosecute individuals who sexually exploit children, and to identify and rescue victims. For more information about PSC, please visit www.justice.gov/psc.

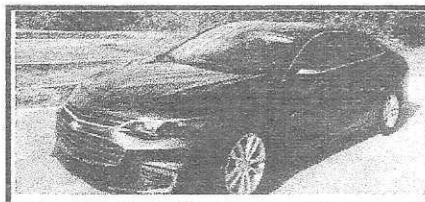

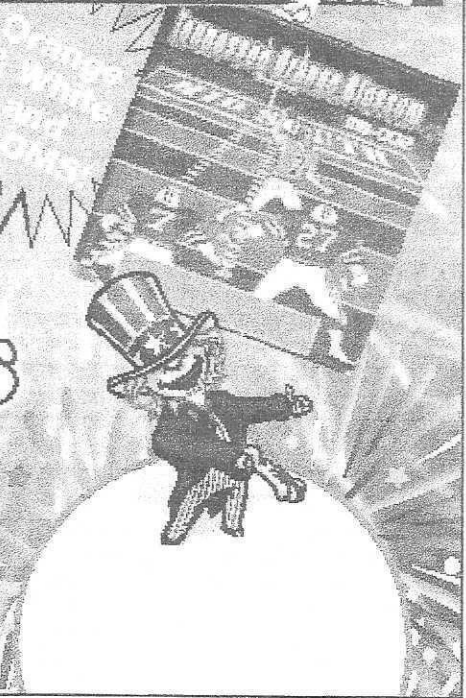

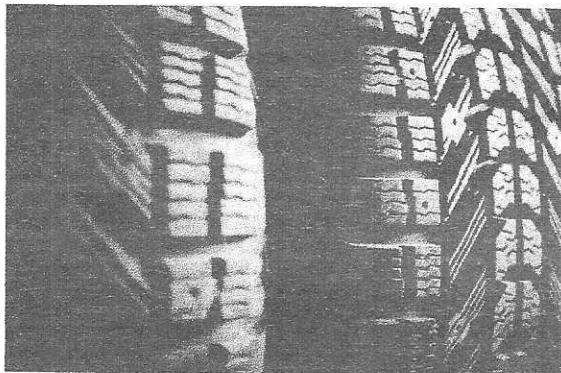
