More illnesses and deaths in Listeria outbreak linked to deli meats is reminder to avoid recalled products

A CDC Food Safety Alert update regarding a multistate outbreak of Listeria monocytogenes infections has been posted at <https://www.cdc.gov/listeria/outbreaks/deli-meats-7-24.html>

Key Points:

Since the last update on August 8, 2024, 14 more illnesses have been reported bringing the total to 57. All 57

people have been hospitalized and 9 deaths have now been reported.

The 6 new deaths include one from Florida, one from Tennessee, one from New Mexico, one from New York and two from South Carolina.

This is the largest listeriosis outbreak since the 2011 outbreak linked to cantaloupe.

Everyone should check their homes for

any remaining recalled Boar's Head products since they can have long a shelf-life. Look for "EST. 12612" or "P-12612" inside the USDA mark of inspection on the product labels. Some of the products have sell by dates into October 2024.

Listeria is a hardy germ that can remain

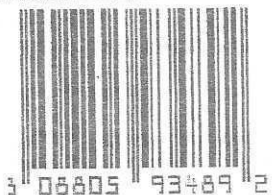

Chapman

Ramona Chapman, 62, Calloway Road Loudon, was charged with, Aggravated Criminal Trespassing, and Assault.

Cpl. Christina Wallen, along with Deputies Brad McCall, Daniel Allen, and Moe Jackson LCSO, responded to Calloway Rd., Loudon on the report of an unwanted

guest. The female caller had told Loudon County Dispatch that there was another female whom she did not know on her property who was refusing to leave. The call taker lost contact with the female caller and could hear a commotion in the background.

Deputy Brad McCall was the first to arrive on the scene at 1749 hrs. At this time, all parties were separated and there was a female standing by a vehicle in the roadway in front of the residence at Calloway Rd. This female, identified as Ramona Chapman (offender), stated that she was a former Loudon County Animal Control Officer and

that she believed the residents at Calloway Rd. were being neglectful of their small dogs, and gave the following summary of the events that had just occurred:

Chapman lives on Calloway Rd., Loudon, and frequently passes by Calloway Rd., Loudon, as she is coming and going to and from her residence. Chapman stated that about a week prior, she passed this residence and saw there were a couple of small dogs in a pen in front of the residence that did not have any shelter, and she noted that there were no vehicles at the residence. She believed that no one was home, so she took it upon her- see Chapman ctd. pg. 3

self to take a small tarp and cover the pen for the dogs to have shade. Chapman stated that on today's date, she was driving past the residence again and noted that the small dogs were once again in the pen without shelter, but noted that there were vehicles in the driveway, and decided to stop and "educate" the dog's owners about the dangers of leaving the dogs without shelter. Chapman states that she knocked on the door, and the resident, (victim, complainant), came to the door, screaming at her "like a crazy person." Chapman said she was asked by the victim to leave the residence, but she refused, and told the victim to "call the cops." Chapman alleges that this is when the victim "attacked" her, shoving Chapman backward off the porch. She stated that the victim then grabbed her by her hair and dragged her to the edge of the road, jumped into Chapman's vehicle, moved the vehicle into the roadway from the victim property, and then told Chapman to get off the property again. This is when Chapman heard the sirens of Deputy McCall's approaching patrol unit, and she waited by her vehicle.

Deputy arrived on the scene at 1750 hrs. As he approached the residence, the deputy observed Deputy McCall standing by a vehicle in the roadway, talking to a female. Deputy Daniel Allen went to Deputy McCall's lo-

cation, and Deputy Moe Jackson and Allen approached the two females who were standing in front of the residence at Calloway Rd., Loudon. One of the females, the victim, identified herself as the homeowner and the original complainant, and the other female, a (witness), identified herself as the neighbor from across the street at Calloway Rd., Loudon. The victim gave the following summary of the events that had just occurred:

The victim was inside her residence when she heard a knock at her door. Upon answering the door, the victim was met by a woman (Chapman), unknown to the victim, who was accusing the victim of being neglectful of her dogs. The victim asked Chapman to leave her property. Chapman refused to leave at the first request and became more aggressive with the accusations of animal cruelty, and advanced towards the victim as she stood in her doorway. The victim believed that Chapman was attempting to enter her residence, and she pushed Chapman backward on the porch, then shut the door behind her to prevent Chapman from entering the residence where the victim minor children were. This is when the victim says Chapman swung at her with a closed fist. The victim then defended herself and her family by grabbing Chapman by her hair and dragging her to the roadway as Chapman continued to swing at the victim, telling Chapman to leave her property multiple times. The

victim then stated that she did get into Chapman's vehicle that was in her driveway, moved it into the roadway, exited the vehicle, and yelled at Chapman again to leave her property. This is when the victim heard the sirens from Deputy McCall's approaching patrol unit, and she waited in front of her residence.

The deputy then spoke to the neighbor, who gave the following summary of the events that had just occurred:

The witness stated that she was inside of her residence when her husband came and got her, telling her that there was a woman at the victim house and the kids were there. As witness exited her residence and began to run over to the victim house, she observed a female (Chapman) pushing the victim in her doorway and swinging at the victim, hitting the victim in the head. Witness then saw the victim pushing Chapman back out of the door and yelling at her. The witness said that as the victim was dragging Chapman off the property, Chapman continued to swing at the victim, telling the victim that she was not leaving. Chapman again advanced on the victim, but the victim got into Chapman's vehicle, moved it from the victim property, and then exited the vehicle. The witness said she stayed with the victim in front of the residence as they heard the sirens from Deputy McCall's approaching patrol unit, and Chapman remained with her vehicle.

Chapman stated to Deputy Allen that she was told to leave the property by Arey many times, but she refused, citing that Arey was breaking the law and told Arey to call the cops instead. Chapman also said that Animal Control has the right to intervene in the instance of animal cruelty, but Chapman is no longer a representative of the Loudon County Animal Control Unit,

and she believed that she did have a right to be on the property. Chapman cited that although Arey told her to leave the property, she knows Arey's landlord and has a right to be on the property.

Based on the statements from all parties involved, I was able to determine that Chapman did knowingly and willingly enter and remain on Arey's property without Arey's effective consent and was reckless about whether her presence would cause Arey to fear for her safety and the safety of Arey's family. Chapman did cause bodily injury to Arey by striking Arey with a closed fist and caused Arey to reasonably fear imminent bodily injury to herself and her minor children when Chapman advanced on Arey in the doorway of Arey's residence. Chapman was taken into custody and charged with TCA 39-14-406 Aggravated Criminal Trespassing and TCA 39-13-101 Simple Assault. Chapman was handcuffed behind her back and the cuffs were checked for proper fit before double locking to prevent tightening. Chapman was then transported by Deputy Dan Allen to the Loudon County Detention Facility without incident.

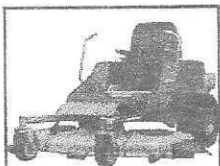
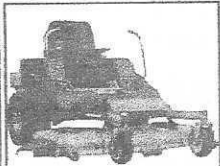
Chapman does not have any minor children in her care who will be left unattended due to her absence. Chapman requested that Deputy Brad McCall park her vehicle in her driveway to avoid incurring a tow bill. Deputy McCall agreed to the request, and the moving of Chapman's vehicle was documented by the dash camera in my unit as well as Deputy McCall's body-worn camera. Deputy McCall parked the vehicle in Chapman's driveway, locked the vehicle, and the keys were given to Chapman after the vehicle was secured. All of the above did occur in Loudon County, TN.

DUI

Kristi Wright, 50, Maple Hill Road Loudon, was charged with DUI, Violation of Implied Consent, Open Container, and Driving on Roadways Laned for Traffic.

Officer H. Wilkes LCPD, was conducting traffic enforcement in the area of U.S. Highway 321 N and City Park Dr. During his patrol duties, the officer observed a gray Mazda, bearing Tennessee registration, 148BLHS, failing to maintain their lane of travel on the public roadway. Additionally, The

officer paced said vehicle traveling 50 miles per hour in a 40 mile per hour zone. A traffic stop was conducted at U.S. Highway 321 N and Elm Hill Rd, where the officer identified the driver to be Kristi Wright. While speaking with Ms. Wright, the officer observed her movements to be erratic and her to have pinpoint pupils. During his roadside interaction, the officer asked Ms. Wright to perform SFST's, to which she consented. During HGN, the officer observed lack of smooth pursuit, distinct and sustained nystagmus at max-

imum deviation, and onset of nystagmus prior to 45 degrees in both eyes. During the instructional phase of the walk and turn, Ms. Wright was observed utilizing his patrol vehicle for balance, and starting too soon. During the walking phase, Mr. Wright stopped while walking, missed multiple heel-to-toe steps, used her arms for balance, made an improper turn, and performed the incorrect number of steps. During the one leg stand, Ms. Wright was observed swaying and putting her foot down. Ms. Wright was asked for consent to search her

vehicle, to which she consented. During the consensual search, the officer located an almost full 12 OZ Twisted Tea can in the front cupholder of the vehicle. Due to the aforementioned, Ms. Wright was placed into his custody. Ms. Wright was read the TN Implied Consent Form, to which she refused. Subsequently, Ms. Wright was transported to the Loudon County Jail without further incident. A licensed operator responded to the scene and recovered Ms. Wright's vehicle for her. All of the above did occur in Lenoir City, Loudon County, TN.

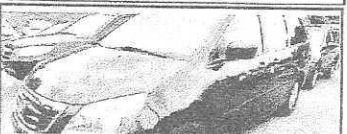

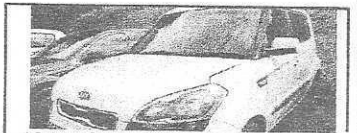

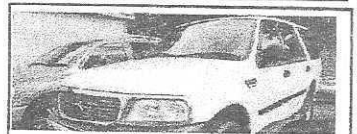

Tonya Johnson, 50, New Hope Road Philadelphia, was charged with Simple Possession.

Officer Bonilla LPD, conducted a traffic stop at New Life Worship Center on Highway 72 N at approximately 10:32am. Upon contact, Ms. Tonia Johnson was discovered to be the driver. The officer stopped Ms. Johnson due to her failing to maintain her lane while traveling East on Highway 72. Ms. Johnson gave the officer consent to search her vehicle. Sergeant Bo Cogdill backed the officer up as she conducted her search. During her search, the officer discovered approximately 0.35 grams of a white powdery substance, believed to be meth, and 2.06 grams of marijuana within Ms. Johnson's purse. Ms.

Johnson was taken into custody and transferred to the Loudon County jail without incident. This did occur in the City of Loudon, TN.

on surfaces, like meat slicers, and foods, even at refrigerated temperatures. It can also take up to 10 weeks for some people to have symptoms of listeriosis.

What You Should Do:

Do not eat recalled deli products. Throw them away or contact stores about returns.

People who are at higher risk for getting sick with Listeria, such as those who are pregnant, are aged 65 or older, or have a weakened immune system, should always avoid eating meats sliced at deli counters, unless heated to an internal temperature of 165°F or un-

til steaming hot just before serving.

Clean your refrigerator, containers, and surfaces that may have touched sliced deli meats.

Call your healthcare provider if you have symptoms of Listeria and recently ate meats sliced at deli counters.

Businesses that received recalled meats should take extra precautions like cleaning and sanitizing and throwing away opened sliced meats and cheeses at delis. Businesses should also follow USDA-FSIS best practices for controlling Listeria contamination in deli areas.

About Listeria:

Listeria can cause severe illness (known as invasive listeriosis) when the bacteria spread beyond the gut to other parts of the body.

Pregnant people typically experience only fever, fatigue, and muscle aches. However, Listeria infec-

tion during pregnancy can lead to miscarriage, stillbirth, premature delivery, or life-threatening infection of the newborn.

People who are not pregnant may experience headache, stiff neck, confusion, loss of balance, and convulsions, in addition to fever and muscle aches.

Symptoms of severe illness usually start 1 to 4 weeks after eating contaminated food with Listeria but may start as early as the same day or as late as 70 days after.

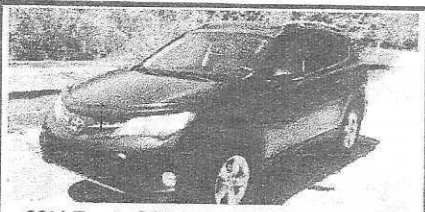

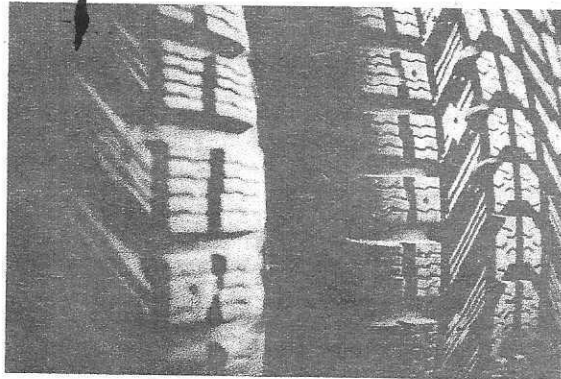
