## Investigative Updates on the New Orleans Bourbon Street Attack

Remarks as prepared for delivery by Deputy Assistant Director Christopher Raia, Counterterrorism Division

Good afternoon, thank you for being here today with the FBI and our partners. Today, we are going to give you the latest update on the FBI's investigation into the Bourbon Street Attack on New Year's Day. First and foremost, I know I speak for the FBI and our first responders when I say that we do this

for the victims and their families—even though we know that nothing we can do will take away their pain and grief, what we can and are doing, is investigating every detail of this attack to find answers. We are leaving no stone unturned.

Before I turn it over to FBI New Orleans SAC Myrthil, I am going to talk a little bit about the overall global and national counterterrorism threat as I think it is important to understand that as it relates to the current

investigation. Make no mistake, protecting the American people from terrorism remains the FBI's number-one priority. The threats from international terrorism, domestic terrorism, and state-sponsored terrorism are complex and persistent—and notably, they are all simultaneously elevated. We continually face threats from foreign terrorist organizations, violent ex-

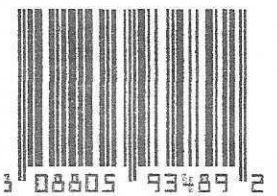

Kenneth Woods, 58, Main Street Loudon, was charged with Aggravated Assault.

Officer A. Luna LPD, was dispatched to the Legion Park Ferry St in reference to a harassment incident involving several dogs and several children. According to witness / victim statements the following happened. The victim was walking two medium sized brown dogs and one large white dog on leashes on the walking track of the park (This is a violation of Park rules). The victim left and said she was going to get a phone at home. She states that she went home and told her husband Mr. Kenneth Woods what was going on. She went back to the park and was in the

process of calling police when Mr. Woods showed up. According to the victim, Mr. Woods threatened them with a gun. According to them he pointed the gun at them and made the statement "Who wants to die today" They also both described the gun as small, black hand gun. When Mr. Woods was approached by Law Enforcement he was in possession of a Beretta 9mm (Small black handgun). After being advised of his Marinda rights Kenneth Woods stated that he followed his wife back down to the park to protect her because she stated that she had been involved in an altercation with the same group over her dogs previously. He says that he was in possession of the afore mentioned firearm because he always carries

a gun. He denies pointing the firearm at anyone. Based on the totality of the circumstances probable cause exist to believe that Woods committed assault as defined by T.C.A. 39-13-101 by intentionally and knowingly placing the victims family in a position to reasonably fear imminent bodily in-

jury or death, while using a deadly weapon (Hand gun) to do so. This did occur in Loudon County, TN 37774.

Publishers Note: There was no indication on the report if the victim was even cited for the park violation that reportedly caused the incident.

Officer Carroll LCPD, responded to Walmart in reference to a Shoplifting call. Prior to arrival, dispatch advised that the male shoplifter was running in an attempt to flee the scene.

According to the report, Upon arrival, the officer observed a black Dodge Ram truck displaying TN tag#BNF7872 trying to drive rapidly through the parking lot. The officer was able to pull up in front of the truck with his department issued vehicle, and started yelling at the male subject to stop his vehicle. The male subject then started to pull forward towards he officer, and the officer pulled out his department issued handgun, and gave verbal commands, to which the male subject did comply.

Officer Carroll, along with Officer Eldridge

were able to take the male subject into custody. The male subject was identified as Jesse Edward Lucas. Mr. Lucas was wearing the clothes that matched the description of the shoplifter, and his vehicle also matched the description based off the information dispatch had given out.

Officer Miller walked up to the vehicle, which had the driver's side door opened still, and observed a piece of burnt aluminum foil. Officer Miller also located a small bag of press m30 fentanyl pills, and another small bag containing a crystal-like substance consistent with Methamphetamine in the center console of the truck. Further into the probable cause search, Officers located a loaded Taurus Millenium PT 145 .45 caliber handgun, along with multiple burnt pieces of aluminum foil, and cut straws which are consistent for drug usage.

Mr. Lucas was transported to the Loudon County Jail without any further incident.

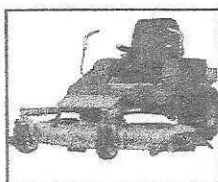
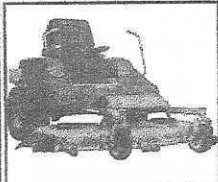

Alfred Barnett, 53, Swan Pond Road Harriman, was charged with, DUI, Possession of Handgun while under the Influence, Open Container, and Failure to Yield Right Away.

Officer Tatham LCPD, observed a red Dodge Challenger turn left in front of an oncoming ambulance identified as Medic 25 who was traveling on Kingston Street. When the vehicle turned in front of Medic 25, they applied their air horn to get the attention of the driver who was turning in front of them causing the Medic 25 to apply the brakes to avoid a collision. The officer then went to go check on the driver who had just failed to yield to the right of way of the oncoming ambulance, upon the officer attempting to exit his vehicle and make contact with the driver the driver began to pull off. The officer

then initiated a traffic stop for failure to yield and made contact with the driver identified as Alfred Joseph Barnett. Upon initial contact with Mr. Barnett, the officer noticed a bottle of Southern Comfort whiskey that was opened and approximately three quarters of the way empty in the center cup holder center console region of the vehicle. Mr. Barnett appeared to be lost, very confused, and having trouble turning off his radio system in his car. Mr. Barnett also showed watery eyes and had slurred speech while talking with officers, while he was reaching for his wallet to retrieve his driver's license, he had to get out of his vehicle in order to do so. After running his driver's license when officers approached Mr. Barnett, the officer noticed a Hi-Point pistol sitting in the passenger seat of the vehicle, while Officer Garren was asking for the registration for the vehicle Of-

ficer Tatham advised Officer Garren to have Mr. Barnett to place his hands on the steering wheel. Officer Garren asked Mr. Barnett if there were any weapons in the car. Mr. Barnett at that point began to reach for the firearm. The officer then opened the passenger door and retrieved the firearm from the vehicle and stored it in his vehicle for safety until the stop was complete. The officer request Officer Garren to perform Horizontal Gaze Nystagmus while he spoke with Lt. Butler who just arrived on scene. Officer Garren advised Mr. Barnett showed great difficulty staying focused on the stimulus for the Horizontal Gaze Nystagmus. The officer then completed the standardized field sobriety walk and turn test and one leg stand. During the walk and turn while giving the instructions of the test Mr. Barnett started the test early and had difficulty keeping the position

as instructed due to loss of balance. During the walking portion of the walk and turn Mr. Barnett stepped off the line multiple times, Mr. Barnett took ten steps down, made an improper turn, and took twelve steps back. During the one leg stand Mr. Barnett put his foot down on two occasions and did not complete the test after putting his foot down the second time. Mr. Barnett was then taken into custody at 9:18pm, he was read implied consent and gave consent for blood and was transported to Fort Loudon Medical Center for blood draw at 9:30pm. The officer arrived at Fort Loudon Medical Center at 9:35pm and the blood draw was conducted at 10:02 pm. The officer then transported Mr. Barnett to Loudon County Jail without incident. The afore mentioned incident did occur in Lenoir City, Loudon County, Tennessee.



tremists across the ideological spectrum, and criminal actors that aim to bring violence to the United States.

During the past few years, lone actors or small cells of individuals who typically radicalize to violence online and who primarily use easily accessible weapons have posed the greatest terrorism threat to our homeland. Lone actors present a particular challenge to law enforcement and intelligence because they are difficult to identify, investigate, and disrupt—especially when their radicalization and communication with other like-minded individuals happens online as is believed to be the case with the New Orleans attacker, Shamsud Din Jabbar. For the past several years, the FBI has provided intelligence to our law enforcement partners highlighting that ISIS calls for vehicle-ramming attacks. This is a tactic that has been used for many years to conduct deadly attacks on U.S. soil and in other countries.

Over the last year, we saw multiple plots in the U.S. that we were able to disrupt along with our state, local, and federal law enforcement partners. Those include plots in September and October in Oklahoma City and New York City, respectfully. The FBI continues to work tirelessly to combat the threat of terrorism, and that includes constantly working with and communicating with our state, local, and federal partners—whether that is sharing intelligence and information or day-to-day coordination on an investigation. And in New Orleans, this is exactly what the FBI and our partners have done since day one.

As it relates to this investigation, all investigative details and evidence that we have now still support Jabbar acted alone in New Orleans. We have not seen any indications of an accomplice in the United States, but we are still looking into potential associates in the U.S. and outside our borders. In any complex terrorism investigation, as we uncover new leads, receive tips from

the public, examine electronic devices, and interview witnesses, the information as we know it evolves into a clearer picture and provides more answers. We are much further along than we were just two days ago and continue to develop a more detailed picture of exactly who Jabbar was.

I also want to take a moment to thank the public for your help so far—you have provided tips that help us piece together this investigation. I don't think the majority of the public knows just how critical their information has been for the FBI in high profile investigations like this one. Their tips and information have been instrumental in the most significant terrorism investigations that have occurred in the last 20 years, so thank you.

The FBI continues to surge resources from across the country to assist the New Orleans Field Office. In addition to FBI special agents and personnel based here Louisiana, more than 200 additional personnel have been brought in to assist in this in-

vestigation in order to process evidence, support victims, and investigate leads and tips. Personnel support includes, but is not limited to, special agents, victim specialists, evidence technicians, specially trained crisis management personnel, and intelligence analysts. FBI offices across the country have also assisted, to include executing search warrants, analyzing evidence, and interviewing associates. Additionally, the entire Counterterrorism Division at Headquarters, along with other Headquarters divisions and the FBI's Critical Incident Response Group, including assets such as the Hostage Rescue Team, continue to work around the clock supporting New Orleans and the other field offices involved in this investigation.

We are not done investigating—the FBI will continue to dig in and investigate to learn all that we can about this despicable attack, on behalf of the victims and for their loved ones.
