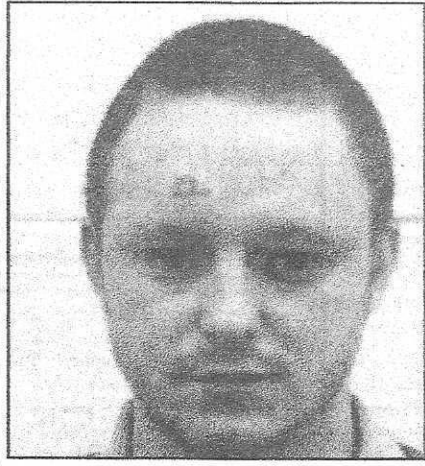

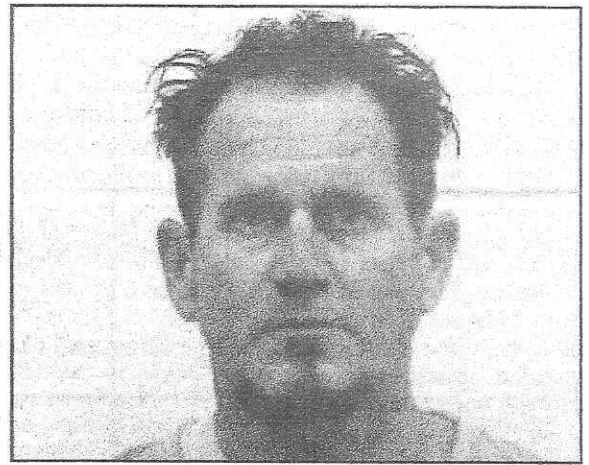

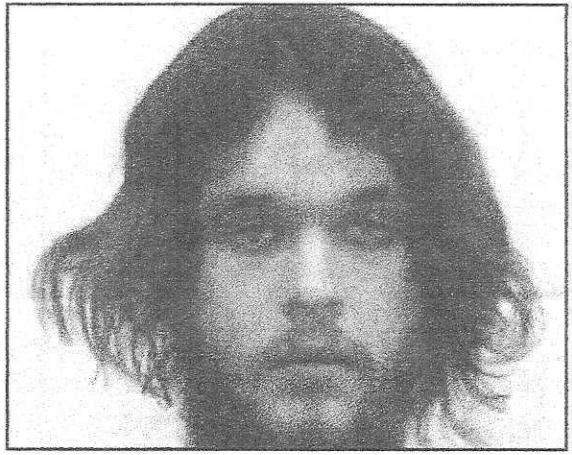

## North Korean IT Workers Conducting Data Extortion

The Federal Bureau of Investigation (FBI) is providing an update to previously shared guidance regarding Democratic People's Republic of Korea (North Korea) Information Technology (IT) workers to raise public awareness of their increasingly malicious activity, which has recently included data extortion. FBI is warning the public, private sector, and international community about North Korean IT workers' continued victimization of US-based businesses. In recent months, in addition to data extortion, FBI has observed North Korean IT workers leveraging unlawful access to company networks to exfiltrate proprietary and sensitive data, facilitate cyber-criminal activities, and conduct revenue-generating activity on behalf of the regime.

Extortion and Theft of Sensitive Company Data

After being discovered on company networks, North Korean IT workers have extorted victims by holding stolen proprietary data and code hostage until the companies

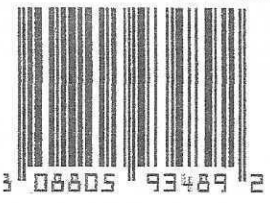

Kristen Campbell, 50, Heidel Lane Wartburg, was charged with, Mfg/Del/Sale or Poss. of Meth, Driving on Revoked/Suspended License, Unlawful Carrying or Possession of a Weapon X2, Possession of a Weapon, and Poss. of Drug Para.

Officer Valletto LPD, conducted a traffic stop on a vehicle that ran a stop sign while turning onto Highway 72. Upon contact with the driver Officer Valletto identified him as Kristen Lee Campbell. Mr. Campbell was asked to provide him with his drivers license and when he did Officer Valletto ran his Drivers license through dispatch and they made we aware that it was suspended indefinitely. Mr. Campbell was asked during our interaction if he would consent to the search of his vehicle and he consented to the vehicle search. While searching the vehicle Officer Valletto located two firearms ( Glock 19, Keltec PMR-30) in the front of the vehicle, five different articles of drug paraphernalia with black residue ( 3 Broken glass pipes, 1 Non broken glass pipe, 1 wooden homemade pipe)

near the front passenger side of vehicle and then a crystal like substance believed to be Methamphetamine weighing 3.38 grams. Upon further investigation Officer Valletto was informed by dispatch that the criminal history the officer requested had been ran on Mr. Campbell and was advised that he is a convicted felon. Mr. Campbell was placed under arrest and charged with driving on a suspended license, Man/Sell/Del/ Schedule 2, Unlawful Drug Paraphernalia, 2x Unlawful possession of a weapon by a prohibited person, Possessing a firearm during the commission of dangerous felony. These actions did occur in the City of Loudon TN 37774.

sister could pick it up. ARWOOD acknowledged CARVER at which time he knew he did not have permission to drive the vehicle. The only registered owner of the vehicle was CARVER. On 01/18/2025, in between the time of 13:45hrs and 13:50hrs, the officer was in the area of Highway 321 near 1104 Highway 321 (KenJo Gas Station) where he observed ARWOOD enter the vehicle belonging to CARVER and exit the parking lot. The officer then initiated a traffic stop on the vehicle in the parking lot of Highway 321 (Rocky Top Shell) located in Lenoir City, TN.

**Murder**

Ashley Sharp, 30, West Cliff Drive Knoxville, was charged with First Degree Murder.

Vincent Ellis, 31, West Clift Drive Knoxville, was charged with, Accessory after the Fact.

Deputy Jackson LCSO, responded to Taylor Drive for a reported shooting. Upon arrival at the scene, the deputy was flagged down by a female, and saw a male, the victim, lying face up in the driveway, with a pool of blood around the left side of his head and upper body. The deputy exited his patrol vehicle to assess the victim and was unable to find a pulse, so the deputy began CPR until EMS arrived on the scene to take over.

After EMS took over the patient, the deputy spoke with complainant, and the following is a summary of

what she told the deputy. Approximately 3 to 5 minutes prior to calling 911, the victim arrived at her camper and asked if he could stay for a while. She said that he could, and the victim returned outside. Approximately 1 to 2 minutes after he went outside, the complainant heard a single gunshot, then her juvenile daughter ran inside saying, "They shot him." the complainant then went outside, saw the victim on the ground, and felt for a pulse; she was able to feel a weak pulse at this time. She then went inside her camper and called 911.

She also told the deputy that Ashley Ellis (Sharp), was the possible offender. Loudon County CID arrived on the scene and took over the investigation. This is an active investigation. This occurred in Loudon County, TN.

**Police beat**

Michelle Long, 49, Hartsook Drive Lenoir City, was charged with Domestic Assault.

Officer G. Butler LCPS, responded to Jim Hartsook Drive Apt. #E8 in reference to a Disturbing the Peace call. Upon arrival, the officer made contact with a male subject at the residence later identified as the victim. While speaking with the victim Officer's observed blood on his shirt and a small cut near the bridge of his nose. The victim stated that the blood was from cutting his finger and denied that there was any altercation with his wife. The victim was then made aware about the complaint of people at the residence arguing to which he stated that it was his son and girlfriend that were arguing earlier but that they had already left. At which point the victim wife Michelle Long appeared in the doorway with a visible mark on her face. During the investigation, while speaking separate-

ly with Officer Fine Michelle stated that her and the victim did have an altercation that she had caused. Mrs. Long stated that her and her husband went to Ayala's Mexican Restaurant for her birthday and that while she was there she did consume multiple alcoholic beverages. Michelle then advised that they then went home after leaving Ayala's and that her and the victim then got into an argument regarding their kids. Michelle admitted to the officer and Officer Fine that during the incident she struck her husband as she was upset and that in self defense he put his hands up to block her from hitting him further which caused the mark observed on her face. Due to the aforementioned and that Michelle Long was determined as the primary aggressor she was then subsequently placed into custody and transported to the Loudon County Jail without further incident. meet ransom demands. In some instances, North Korean IT workers have publicly released victim companies' proprietary code.

North Korean IT workers have copied company code repositories, such as GitHub, to their own user profiles and personal cloud accounts. While not uncommon among software developers, this activity represents a large-scale risk of theft of company code.

North Korean IT workers could attempt to harvest sensitive company credentials and session cookies to initiate work sessions from non-company devices and for further compromise opportunities.

**TIPS TO PROTECT YOUR BUSINESS**

Recommendations for Data Monitoring

Practice the Principle of

Least Privilege on your networks, to include disabling local administrator accounts and limiting privileges for installing remote desktop applications.

Monitor and investigate unusual network traffic, to include remote connections to devices or the installation/presence of prohibited remote desktop protocols or software. North Korean IT workers often have multiple logins into one account in a short period of time from various IP addresses, often associated with different countries.

Monitor network logs and browser session activity to identify data exfiltration through easily accessible means such as shared drives, cloud accounts, and private code repositories.

Monitor endpoints for the use of software that allows for multiple audio/video calls to take place concurrently.

**Recommendations for Strengthening Remote-Hiring Processes**

Implement identity-verification processes during interviewing, onboarding, and throughout the employment of any remote worker. Cross-check HR systems for other applicants with the same resume content and/or contact information. North Korean IT workers have been ob-

served using artificial intelligence and face-swapping technology during video job interviews to obfuscate their true identities.

Educate HR staff, hiring managers, and development teams regarding the North Korean IT worker threat, specifically focusing on changes in address or payment platforms during the onboarding process.

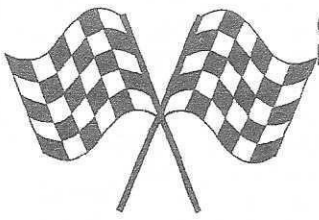

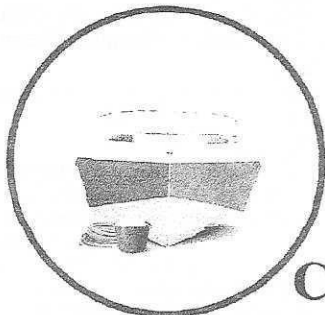
