## State Rep. Lowell Russell announces applications open for Rescue Squad Grant Program

Application window closes at 1 p.m. EST on Feb. 21

State Rep. Lowell Russell, R-Vonore, is encouraging local rescue squads to apply for grant awards through the state's Rescue Squad Grant Program.

The 113th General Assembly approved \$3 million in grant funding for Tennessee rescue squads to purchase lifesaving equipment. Rescue squads provide a range of specialized

services including extrication, structural collapse response and swift water rescue. Through two grant cycles, the program has provided \$5 million to local rescue squads.

"Rescue squad equipment can be a significant financial strain for many local organizations, and this grant program aims to alleviate that cost," Russell said. "This is an excellent opportunity to pro-

vide lifesaving equipment to communities across the state and I urge every eligible department to apply."

Awards are administered by the Tennessee Department of Commerce & Insurance (TDCI) and the Tennessee State Fire Marshal's Office. Grantees are able to purchase equipment for incident response and to pro-

Thomas Fortune, 46, Donaldson Road Philadelphia, was charged with, Resisting Arrest, Violation of Probation x2, Evading Arrest, Driving on Revoked/Suspended License, Speeding, and General Session Capias.

Deputy Reagan LCSO, while patrolling the area of McCrary St and Donaldson Rd, observed Thomas Fortune (Arrestee) outside of Donaldson Rd Lot 6. While driving through Donaldson Rd, the deputy recognized the address as the residence where Thomas Fortune could be staying. As the deputy passed the residence, he observed a Subaru vehicle with the hood up in the driveway. Along with the vehicle, the deputy observed legs under the vehicle, but the deputy could not see the top half of the person. As the deputy drove past, the person moved along the Subaru, making sure that it was between them and his vehicle. At that time, the deputy stopped and observed the person looking under the Subaru. The deputy exited his vehicle, and the person began running toward the front door of the house. The deputy made announce-

ments and told the person to stop. While announcing, the deputy began pursuing on foot and the male turned around. From his turning around, the deputy was able to positively identify the male as Thomas Fortune. The deputy had prior knowledge of active warrants that were issued for Thomas Fortune out of Loudon County General Sessions Court. Fortune entered the home, and the deputy ran around the residence to establish a perimeter and to assess how many possible exits that were attached to the house. The deputy made announcements, calling Fortune by name to exit the house with his hands up, with no response. While covering the residence. Swat Team members and patrol supervisors arrived on the scene to assist. Cpl. Sartin, Sgt. Rogers, and Deputy McCall assisted Reagan with establishing a better perimeter. Lt. Ezell and other Swat Team members began establishing plans to get residents out of the home as well as Fortune, in the safest possible way. Cpl. Sartin began making callouts through his P.A. system in his vehicle. A male was the first person to respond to the commands given. He exited the residence and followed

commands without further incident. The male gave Deputies information about where Fortune was hiding inside the home. He stated that he had hidden in a closet that had a false wall. The closet was located in the bedroom to the right when walking in from the front door. After more

callouts were made from Cpl. Sartin, Melany O'Daniel (Arrestee) exited the home with two dogs. She followed commands, was detained, and placed in the back of a patrol vehicle. Lt. Ezell began speaking with O'Daniel and made statements that contradicted Swat ctd. pg. 3

information that had already been gathered. She was put on notice by Lt. Ezell from prior incidents involving Fortune. She was told that she could be charged for harboring him. O'Daniel attempted to inform Fortune of plans to apprehend him via text message. After speaking with her further, she confirmed that he was hidden behind the false wall in the aforementioned closet. Swat Team members arrived on the scene with an armored vehicle and made callouts. A short time later, Fortune exited the residence with his hands empty and up. He followed commands and was placed into custody. The deputy placed him in the back seat of his patrol car and the Swat team cleared the residence. The deputy transported Thomas Fortune to the Loudon County Jail without further incident. This did happen in Loudon County, TN.

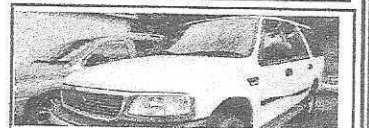

In order to apply, the organization must have an active registration with the Tennessee Secretary of State and provide a letter stating they are recognized by the local government to provide rescue squad services.

Once submitted, applications are scored internally and given to a seven-member committee who oversees the award selection. The committee is composed of six members from the Tennessee Rescue Squad Association, and the TDCI's Assistant Commissioner of Fire Prevention.

theft. Mr. Espinosa used the credit/debit card information at the Food City on Highway



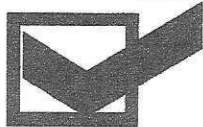
