Fausto Isidro Meza-Flores Added to FBI's Ten Most Wanted Fugitives List

The U.S. State Department's Narcotics Rewards Program is offering a reward of up to \$5 million

In a video statement addressed to the public, FBI Acting Director Brian Driscoll announced that the FBI added Fausto Isidro Meza-Flores to its Ten Most Wanted Fugitives list.

"Known as El Chapo Isidro, he's accused of spending

the last 20 years flooding the U.S. with fentanyl, cocaine, heroin, and other deadly drugs, first as an independent drug trafficker and later as the head of the Meza-Flores cartel," said Acting Director Driscoll. "In addition to the scourge of illicit drugs Meza-Flores and his organization have unleashed into the United States from across our southern border, they're also accused of

heinous crimes ranging from kidnapping and extortion to torture and murder."

Meza-Flores was originally indicted on May 2, 2012, in the U.S. District Court for the District of Columbia. On November 26, 2019, a federal grand jury returned a superseding indictment charging Meza-Flores with drug trafficking see **FBI** pg. 5

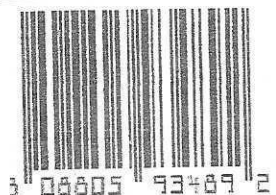

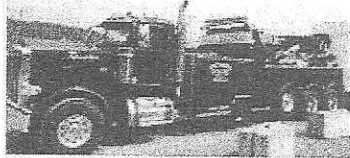

Officer Jenkins asked if there was any marijuana in the vehicle in which Morris told officers she had a little bit in the car. Officers conducted a Probable Cause search in which Officers discovered an orange backpack located behind the drivers seat to contain 124 grams of a green leafy substance believed to be marijuana, several containers with residue of "dab" a THC oil concentrate, a "grinder" commonly

used for shredding marijuana, a pipe with residue and several cut straws. Officers discovered a "Roach" also know known as a burnt marijuana cigarette. Officers also discovered a scale and a box of sandwich bags in backpack as well. Officer Flynn located a white powdery substance believed to be Fentanyl wrapped in a receipt located in Morris's purse. Officer Flynn also Discovered THC gummies in Morris' Purse. Officer Flynn tested the substance using a NARK II testing kit in which the powder tested positive for Fentanyl.

Aundrea Walton, 47, Slab Town Road Sweetwater, was charged with Aggravated Assault.

Deputy Eric Curtis LCSO, was dispatched to Slab Town Rd in reference to a trespassing. Upon arrival, Curtis and Deputy B Lewis made contact with the complainant and offender, Aundrea Walton. According to Walton, her neighbor the victim was driving around recklessly and pulling a chair behind his truck with a person in it. While doing so, the victim allegedly slung the occupant onto Walton's property. Walton has had repeated issues with the victim in the past and feared legal recourse. She walked down to the road and advised them to leave. The parties in the truck drove away and then returned, turning around in the same area. She again in-

structed them to leave. They pulled out and returned a third time, this time with the victim in the chair. After they turned around, Walton produced a .22 caliber Derringer and fired two rounds into the air. She then told the driver to leave and that she was serious. Deputies B Lewis and Cpl. J Sartin interviewed the other party and acquired written statements from those involved. Deputy Curtis then read Walton her Miranda Rights prior to completing a written statement, which she acknowledged and signed. Walton completed a written statement of her own. Both parties admitted to the gun being fired, and the victim stated that he was in fear for his safety. Due to allegations that Walton had contracted the COVID-19 virus, no arrest was made at the time of the report. This did occur in Loudon County, TN.

Deputy Owens LCSO, was on his way to assist another officer during a call for service when the deputy noticed a truck traveling a vehicle ahead of him all over the roadway. The deputy activated his emergency equipment to catch up to the car and conduct a traffic stop as the deputy observed the truck enter the opposite lane while failing to maintain its lane. After catching up to the vehicle, it continued to roll and stopped at a red light at the intersection of Highway 70 and Highway 321. The deputy walked up to the car to make contact


with the driver and advise them to move over out of the roadway and when the window was lowered the deputy immediately noticed the driver to have glossy, bloodshot eyes and the driver seemed disoriented. The deputy followed the vehicle to Weigel's and conducted his investigation. The deputy could immediately smell the odor of an alcoholic beverage emitting from his person. The driver was identified as Jean McGuire. The deputy asked Jean if he had been drinking and he said he had three drinks earlier in the night. McGuire's speech was slurred. The deputy asked McGuire to step out of the vehicle and when he did so he stumbled as if he had trouble standing and keeping his balance. The deputy asked McGuire if he would perform standardized field

sobriety and he declined. The deputy advised that based on the totality of the circumstances he believed him to be operating a motor vehicle on a public roadway while being intoxicated. McGuire was then placed under arrest for driving under the influence. An inventory search of McGuire's vehicle revealed there to be a loaded .9mm P365 handgun in his passenger seat inside of a handbag. McGuire initially agreed to provide a blood sample for


testing but changed his mind once at the hospital and refused. He was then transported to the Loudon County Jail without incident.

violations and possession of a firearm. According to the indictment, Meza-Flores allegedly conspired to manufacture and distribute cocaine, heroin, methamphetamine, and marijuana in the U.S. from 2005 to 2019.

Meza-Flores is 42 years old and has dark brown hair and brown eyes. He is 5'6" tall and weighs about 160 pounds. He also goes by the nicknames "Chapo Isidro" and "Chapito Isidro."

Meza-Flores is a Mexican national and likely resides in Mexico. He is considered

armed and dangerous and is an international flight risk.

"The U.S. government is offering a reward of up to \$5 million for information leading to his arrest and conviction, and we encourage anyone with information about his whereabouts to contact the FBI and help us add Meza-Flores to the list of dangerous fugitives we've brought to justice together," said Acting Director Driscoll.
