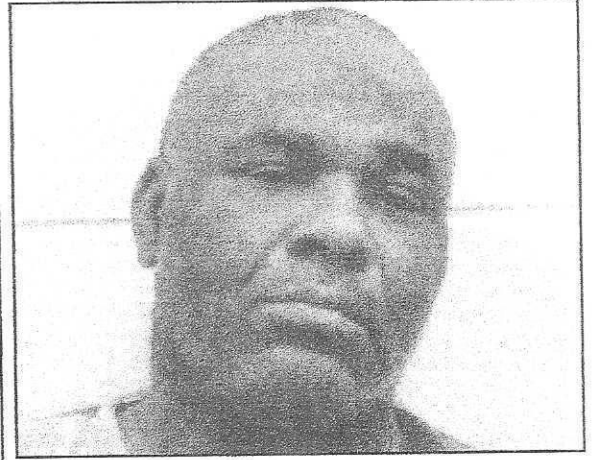

First H5 Bird Flu Death Reported in United States

CDC is saddened by Louisiana's report that a person previously hospitalized with severe avian influenza A(H5N1) illness ("H5N1 bird flu") has passed away. While tragic, a death from H5N1 bird flu in the United States is not unexpected because of the known potential for infection with these viruses to cause severe illness and

death. As of January 6, 2025, there have been 66 confirmed human cases of H5N1 bird flu in the United States since 2024 and 67 since 2022. This is the first person in the United States who has died as a result of an H5 infection. Outside the United States, more than 950 cases of H5N1 bird flu have been reported to the World Health Organization; about half of those have resulted in

death.

CDC has carefully studied the available information about the person who died in Louisiana and continues to assess that the risk to the general public remains low. Most importantly, no person-to-person transmission spread has been identified. As with the case in Louisiana, most H5 bird

totalled \$537.68. This incident did take place within Lenoir City, Loudon County, TN.

On 12/22/2024 at approximately 2041 hours, officers with the Lenoir City Police Department went to Old Highway 95 in reference to an Attempt to Locate on a Christina Leopper for warrants issued on Burglary and Shoplifting. While going to the house, they observed Ms. Leopper driving a Maroon Ford Escape pulling onto her street. Officers initiated a traffic stop on the vehicle due to having prior knowledge of Ms. Leopper having a revoked license. Ms. Leopper has been revoked since June of 2021. Officers then had her step out. Ms. Leopper was read her Miranda Rights by officer Fine and she agreed to speak with us. Officer Green then questioned her about the theft at Walmart. She admitted to putting three mixers into her shopping cart and walking out of the store with them. She also stated that she sold all three of them on the Facebook Marketplace for \$100 a piece. The officer then asked her if she knew who she sold them to and she stated no. Ms. Leopper was then placed into custody and transported to the Loudon County Jail without further incident. All the above did occur in Lenoir City, Tennessee.

Order

Jason Roberts, 37, Highway 72 Loudon, was charged with Violation of Order of Protection.

Deputy Allen LCSO, arrived at Highway 72 for the report of a 911 misdial. Loudon County E-911 advised that Jason Roberts had called 911. Mr. Roberts stated it was an accidental dial. Loudon County E-911 advised that they could hear him talking to a female. Deputy checked Mr. Roberts's driver's license while he was responding. Loudon County E-911 found he was the respondent on an order of protection. The protected party was the female. As the deputy exited his patrol unit on the scene the victim exited a red Ford Explorer in the driveway. The victim stated Mr. Roberts was inside working on the home. The victim stated as far as she knew the order was still in place until 02/11/2025. Mr. Roberts was taken into custody at this time without incident. Mr. Roberts was transported to the Loudon County Jail without incident.

Ann Flores, 45, Ash Avenue Lenoir City, was charged with, Mfg/Del/Sale or Poss. of Meth, and Poss. of Drug Para.

Officer R. Miller, with the Lenoir City Police Department initiated a traffic stop on a maroon Ram pickup truck in the parking lot of Highway 321 (Ez Stop) located in Lenoir City, TN for an improper display of registration. The registration on the pickup came back to a Jaguar sedan. Upon the traffic stop the officer made contact with the driver, and rear backseat passenger Ann Flores. During the traffic stop the driver admitted that he had a small marijuana joint inside of the pickup truck at which time the officer had both he and FLORES step out of the pickup truck. At this time, the officer could smell an odor of marijuana

emitting from the driver and from inside of the pickup truck. A probable cause search of the pickup truck was then conducted. During the subsequent search of the pickup truck, the officer located a black digital scale inside of the center console and a small glass pipe inside of a wooden box located in the middle front floorboard of the pickup truck. Further into the search the officer located a cigarette carton that was located next to the passenger's side "B Pillar" that contained a crystal-like substance believed to be methamphetamine (approximately 1.85 grams). The cigarette carton was located near the feet where FLORES was sitting inside of the pickup truck. Located inside of FLORES'S purse was a glass pipe that contained a white residue which was consistent with methamphetamine. Both FLORES and the driv-

er were mirandized at which time FLORES admitted to smoking methamphetamine earlier in the morning but stated that the crystal-like substance did not belong to her. Where the crystal-like substance was located at inside of the pickup truck was in the constructive possession of FLORES.

The victim is still deprived of \$6,689.00. The victim is willing to prosecute. All of this did occur in Loudon County, TN.



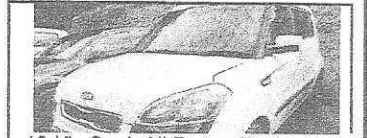

flu infections are related to animal-to-human exposures. Additionally, there are no concerning virologic changes actively spreading in wild birds, poultry, or cows that would raise the risk to human health. (CDC reported previously on its analysis of the viruses isolated from the patient in Louisiana.) However, people with job-related or recreational exposures to infected birds or other animals are at greater risk of infection. For these and others, CDC has developed prevention resources about how to protect yourself.

CDC is continually:

Supporting critical epidemiologic investigations with state and local partners to assess the public health impact of each H5 case.

Working closely with state and local partners to conduct active surveillance for H5 cases.

Monitoring for changes that might suggest H5 viruses are becoming better adapted to mammals and therefore might spread more easily from animals-to-humans or human-to-human or cause more severe disease.

Monitoring for any viral changes that could make these viruses less responsive to flu antiviral medications or the available candidate vaccine viruses.

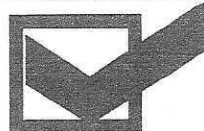

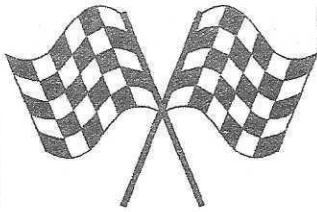

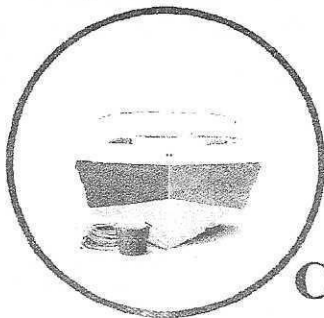
