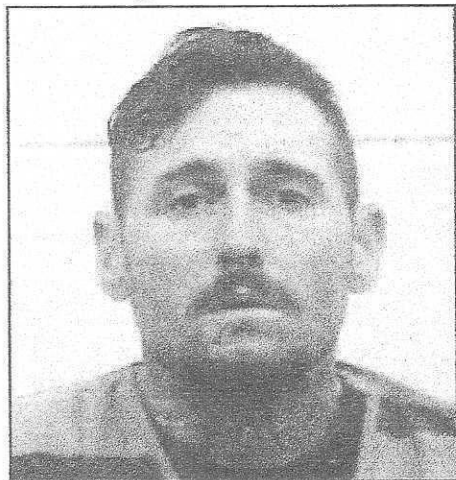

## Threat of Copycat Attacks after ISIS-Inspired Vehicle Attack in New Orleans

The Federal Bureau of Investigation (FBI) and Department of Homeland Security (DHS) are issuing this Public Service Announcement to highlight a potential public safety threat from violent extremists in response to the New Year's Day attack in New Orleans, Louisiana. As with any potential threats to the United States, we will coordinate with our state and local law enforcement

partners to ensure they have the resources and information necessary to keep our communities safe.

### THREAT

The FBI and DHS are concerned about possible copycat or retaliatory attacks due to the persistent appeal of vehicle ramming as a tactic for aspiring violent extremist attackers. Previous attackers inspired by foreign terrorist organizations (FTOs) who have conducted vehicle attacks in the United

States and abroad have used rented, stolen, and personally owned vehicles, which are easy to acquire. Some have used additional weapons, such as firearms and knives, to attack individuals after the vehicle has stopped. Additionally, attackers may attempt to conceal and pre-position improvised explosive devices (IEDs) to supplement a vehicle

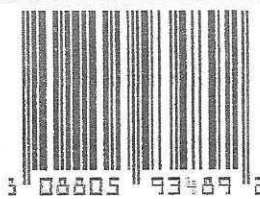

### Evading

Devin Hills, 26, Old Niles Ferry road Greenback, was charged with, DUI, Evading Arrest, Reckless Driving, and Violation of Implied Consent.

Deputy Brockwell LCSO, was sitting at the Greenback Corner Market watching traffic on Highway 411 when he observed a black dodge challenger pass him at a very high rate of speed. The way the deputy had his car placed, with his spotlight shining on the road, was so that traffic coming from both directions on Highway 411 could see him. The deputy observed a Black Dodge challenger with blacked out

windows pass him at a high rate of speed and showed no indications of slowing down. At this time, the deputy initiated his emergency equipment and attempted to catch up to the vehicle. The deputy advised dispatch to notify Blount County with the vehicle description. While trying to catch up to the vehicle, speeds got up to over 130 mph. Even with the speeds this high the Challenger continued to gain distance on him and was showing no signs of stopping. The deputy caught up to the vehicle at Henry Lane with speeds now at 60 mph and notified dispatch he was in pursuit. While being directly behind the vehicle, it continued to

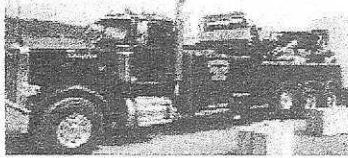
drive for another 30 seconds before stopping on the shoulder. The deputy asked the driver/offender, Devin Hills, to step out of the vehicle and walk to his patrol car placing his hands on the hood of his car. Hills obeyed these commands, and the deputy placed Hills under arrest for evading arrest and reckless driving. The deputy placed Hills in the back of his patrol car, and he was advised of his rights. While speaking with Hills, there was a strong odor of an alcoholic beverage coming from his breathe and he stated that he realized running was a bad idea that's why he stopped. He also stated that he saw the deputy sitting at the Greenback

Corner Market watching traffic. The deputy asked Hill if he had consumed any type of alcoholic substances tonight, and he stated that he had not been drinking. The deputy then asked Hills if he would be okay with performing Standardized Field Sobriety Tests (SFSTs) to make sure he was safe to operate a motor vehicle on a public roadway, Hills refused. Awaiting on a tow truck to arrive on scene, the deputy did an inventory search on the vehicle. While inventorying the vehicle, there was a strong odor of an alcoholic beverage coming from the vehicle. The deputy observed a 12 pack of Miller Lite (alcoholic beverage) sitting at the Greenback

Officer R. Miller LCPD, conducted a traffic stop on a white Jeep SUV in the parking lot of Taco Bell, located in Lenoir City, TN. The vehicle was operating on a public roadway during inclement weather (rain) while not having the vehicles headlights or taillights on while the windshield were operating. Upon the traffic stop the

officer made contact with the male driver who was later identified as Jonathon McKeever and the front seat passenger/owner of the vehicle, Ashley Wilson. Then officer then had MCKEEVER step out of the vehicle to speak with him further about a citation. During the traffic stop K9 Deputy D. Harrison of LCSO respond to my location where K9 Draco conducted an open-air sniff of the white Jeep where the officer was advised he positively alerted to an odor of narcotics. Prior to my probable cause search of the vehicle the officer noticed items in the pockets of both WILSON and MCKEEVER. The officer asked WILSON about the items in her pocket where she pulled a bag of a white powdery substance from her front left jacket pocket. The white pow-

der weighed approximately (9.49 grams) and tested positive for Alprazolam using the Tru Narc Drug Analyzer. WILSON also produced a small blue half pill (Y 20) from her front left jean pocket, the pill was identified to be Alprazolam 1 mg. The officer then conducted search of MCKEEVER'S pockets where he located an uncapped hypodermic needle in his right coat pocket and then located a cigarette carton in his inner coat pocket which

contained a crystal-like substance that tested positive for Methamphetamine using the Tru Narc Drug Analyzer (Approx Weight - 3.86 grams) along with a bag of a white powdery substance believed to be Fentanyl (Approx Weight - 0.49 grams). Also located inside of the cigarette carton was a black cut straw that contained a white powdery-like residue.

During the investigation, MCKEEVER was shown to have a suspended license.

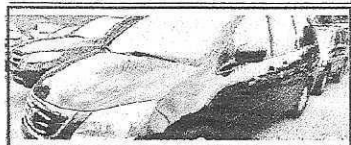

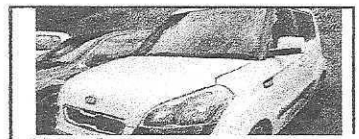

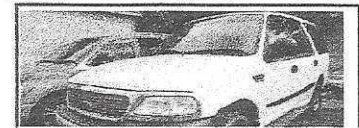

attack. Targets have included pedestrians, law enforcement or military members, and crowded public venues, including festivals and commercial centers, which generally are accessible from roadways. We ask that the public remain vigilant regarding possible copycat or retaliatory attacks and report any suspicious activity to law enforcement.

**RESOURCES**

The FBI and DHS encourage the public to promptly report information concerning suspicious activity to tips.fbi.gov or contact their local FBI field office (www.fbi.gov /

contact-us/field-offices). Call 911 to report emergencies, including imminent threats to life.

To help mitigate potential risks from a variety of threat actors, DHS, the FBI, and the National Counterterrorism Center have compiled resources for law enforcement officers, other first respond-

ers, faith leaders, and communities, including a list of funding opportunities, resources for technical assistance, and educational materials.

Due to the highly personal nature of radicalization to violence and mobilization to violence, it can be difficult to assess specific characteristics indicating the intent of US-based violent extremists to conduct violence. The FBI and DHS urge bystanders to promptly report suspicious activities potentially related to violent extremist activity, including indications of possible online radicalization to violence and mobilization for attacks.

DHS, the FBI, and NCTC

direct public safety partners to the unclassified booklet "US Violent Extremist Mobilization Indicators 2021 Edition," which includes possible indicators of mobilization to violence. These indicators apply to all ideologically motivated, US-based violent extremists. DHS also has developed several unclassified resources for communities to help promote bystander awareness of potentially threatening or concerning behaviors that are observable to others and enhance the capacity to identify and mitigate threats through behavioral threat assessment and management, including publicly available training and prevention guides.
