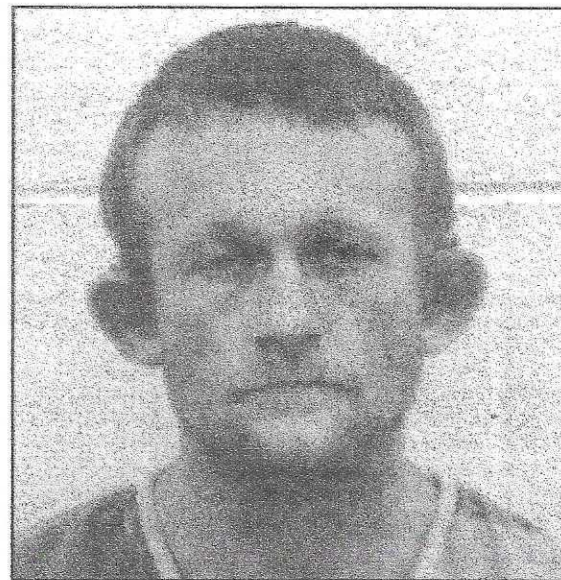

TBI Agents Arrest, Charge Meigs County Man in Georgetown Arson Investigation

Tennessee Bureau of Investigation special agents specializing in fire investigations, working alongside the Meigs County Sheriff's Office, have arrested and charged a Georgetown man in connection with an arson investigation.

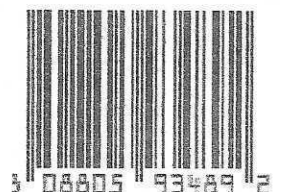
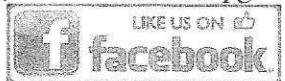

Gang

A Loudon financial institution suffered a loss of approximately \$66,000 several days ago when four or five individuals pulled up to the ATM and accessed the ATM evidently using a key for opening the machine. It is suspected the thieves have obtained a 'master' key or similar key to these types of ATMs. Video footage of the event led authorities to suspects involved in similar thefts in other parts of East Tennessee and even other states in the Southeast. They are suspected of being members or associated with the notorious Venezuelan gang – Tren de Aragua, or TdA. This is same gang that


has been essentially labeled at terrorist organization by the Trump Administration where the Federal Government was deporting TdA gang members until halted recently from doing so by a federal judge.

Loudon Police Department Detective Brian Jenkins is investigating the case and working with Homeland Security – ICE. He has written felony theft warrants placing them in the NCIC system. As a result, authorities in Harvey County, Kansas have arrested three of the suspects and District Attorney General Russell Johnson recently issued an extradition request to place holds on them for potential removal back to Loudon and prosecution on the warrants. The District Attor-

ney's Office is working through the various issues with the local authorities in Kansas and with ICE to determine whether it is more expedient to bring them back for prosecution, especially in light of the federal court hold on deportation, or to de-

fer to the federal authorities to take them to a federal holding facility.

He is also reaching out to other East Tennessee district attorneys whose counties have been hit to coordinate the prosecution efforts.

Stevie Colon, 38, Kagley Drive Lenoir City, was charged with, Mfg/Del/Sale or Poss. of Meth, Simple Possession, and Driving on Revoked/Suspended License.

Deputy K. Palmer LCSO, observed a black Toyota Camry traveling west on Highway 444 at a high rate of speed. Using radar, the deputy clocked the vehicle going 62 mph in a 50 mph zone. The deputy stopped the vehicle on Coyatee Road, just off Highway 444, at which point he made contact with the driver. The driver who, did not have a valid driver's license. Her mother, Ms. Stevie Colon, who was sitting in the back seat, stated that she had a valid license and was aware that the driver, did not have a license but allowed her to drive for practice. The deputy requested Ms. Colon to exit the vehicle. As she stepped out, a baggie fell to the ground containing what appeared to be methamphetamine. The deputy

instructed Ms. Colon to put her hands behind her back, and at that moment, she dropped another baggie with white residue. After detaining Ms. Colon, the deputy asked her to walk to his patrol vehicle, during which another baggie fell to the ground, containing a crystal substance believed to be methamphetamine. Ms. Colon was placed under arrest and transported to the Loudon County Jail. There were approximately 1.26 Grams of Methamphetamine, and 1.36 Grams of THC wax seized from the traffic stop. Additionally, the vehicle's driver, was cited for driving without a license and speeding. 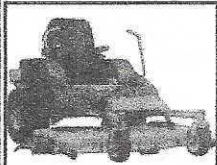

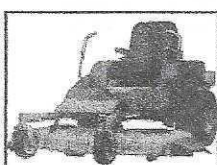

Crystal Jones, 46, Heather Glenn Drive Maryville, was charged with, Mfg/Del/Sale or Poss. of Meth.

Deputy Edgmon, and Deputy Allen LCSO, made contact with a suspicious vehicle on Morganton Cemetery Road at the boat ramp. We observed the vehicle travel in a circle in the parking lot and proceed to the exit/entry. Upon our arrival, the vehicle turned away from the deputies and pulled into a parking spot. Deputy Allen pulled the patrol vehicle behind the suspicious vehicle. The suspicious vehicle had a clear lane of travel in front of it. The deputy noted an improper display of registration that consisted of a license plate cover restricting the view of the county and state on the license plate. Upon making contact with the driver, Crystal Jones,

the deputy smelled the odor of marijuana coming from the vehicle. Ms. Jones was removed from the vehicle. Ms. Jones advised there was methamphetamine located in the vehicle. The suspected methamphetamine was located on the driver-side seat. Ms. Jones was placed under arrest without incident. The vehicle was turned over to Ms. Jones' family. Ms. Jones was transported to Loudon County Jail by Deputy Knight without incident. The suspected methamphetamine was transported to Loudon County Sheriff's Office and weighed at 0.9 grams. This did occur in Loudon County, Tennessee.

During the course of the investigation, authorities determined that the property owner, James Harry Burch (DOB 10/10/1958), was the individual responsible for starting the fire.

Burch was arrested on March 19th and charged with one count of Arson, one count of Burning Personal Property, one count of Filing a False Report, one count of Tampering with Evidence, one count of Insurance Fraud \$10,000-\$60,000, and one count of Insurance Fraud \$60,000-\$250,000. He was booked into the Meigs County Jail on \$25,000 bond.

The charges and allegations referenced in this release are merely accusations of criminal conduct and not evidence. The defendant is presumed innocent unless and until proven guilty beyond a reasonable doubt and convicted through due process of law.

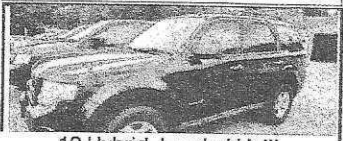

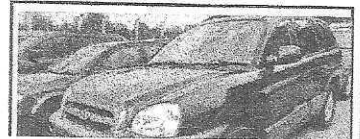

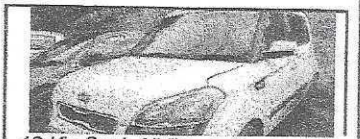

Tony Fugate, 38, Gilbert Lane Knoxville, was charged with, Assault x2, and Public Intoxication.

Deputy Miller LCSO, saw a male walking with a can in his hand on Martel Road at around 9:20 PM. The deputy parked his patrol car across the street from Calloway Circle and asked the individual if he would come to speak with him. The deputy immediately smelled a strong odor of alcoholic beverage on the male's person. The man was identified as Tony Fugate Jr. The deputy asked him where he was headed, and he stated to his friend's house down the road that his car wasn't running properly, so he left it at the UGO at the end of Martel. He was unable to tell the deputy his friend's name; he just said that they were involved in "Creedence" together. He later stated "Creedence"

was a program started by "Conrad" to get drugs off the streets. At this time, Cpl. Wallen arrived on the scene and asked Mr. Fugate how much he had to drink. He stated he was drinking a 25 oz beer while walking down the street and that he had thrown it in the ditch before the deputy made contact with him. He then made the statement that he was in Maryville and didn't come here often.

He stated he had been door dashing earlier and the house he was going to was a house that he had delivered to earlier and that he was communicating with them by text. He said he lost his phone before he started walking after "falling in a cemetery." Given the totality of the circumstances with Mr. Fugate not being aware of his present location, his incoherent itinerary, and Mr. Fugate's admission to drinking,

The deputy determined that Mr. Fugate was under the influence of a drug or intoxicant that left him unable to care for his own safety. Mr. Fugate was placed under arrest for Public Intoxication.

While in the block Inmate victim 1 hung the phone up and walked over to the sink and was talking to inmate victim 2 when inmate Tony Fugate approached inmate victim 1 from behind and with a closed fist struck inmate victim 1 in the facial region causing victim 1 to go unconscious and fall to the ground. Inmate victim 1 was then transported to Fort

Loudon Medical Center per Nurse Hannah. While watching cameras it was seen that approximately 1223 hours Inmate victim 2 was walking towards the shower when inmate Tony Fugate approached inmate victim 2 from the side and with a closed fist struck inmate victim 2 in the facial region. Inmate victim 2 then defended him self and took inmate Fugate to the ground. Inmate Tony Fugate was seen by medical and then removed from the pod placed in isolation for the safety of inmates and deputies.

This did occur at the Loudon County Detention Center in Loudon, TN.
