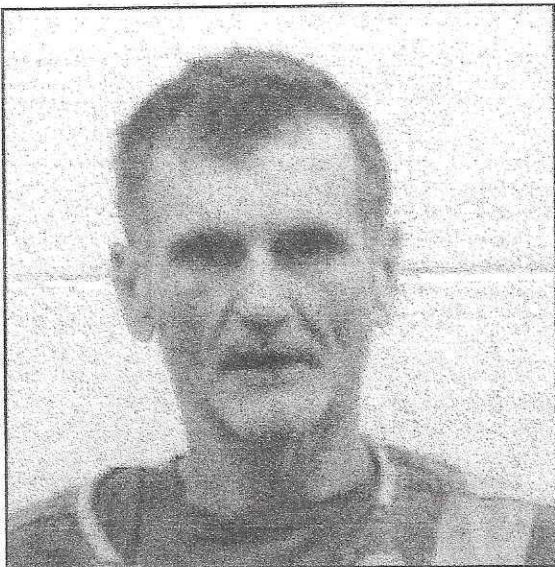

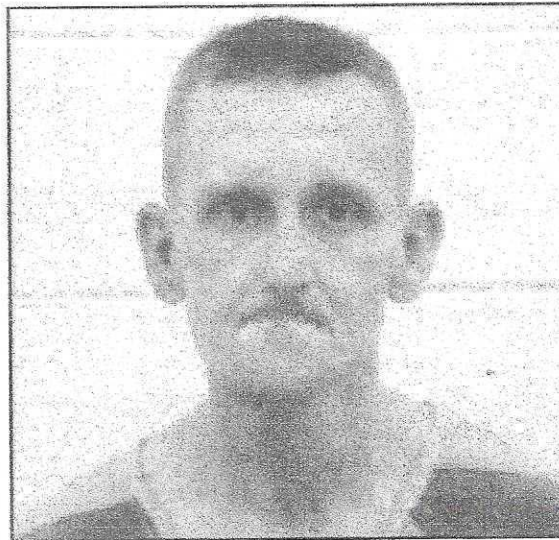

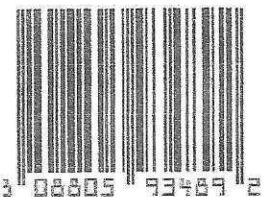

Jermichael Campbell, 24, Sunset Avenue Knoxville, was charged with Mfg/Sell/Del/Resale Sch. VI.

Jasmine Lansden, 24, Chestnut Street Chattanooga, was charged with Mfg/Del/Sale/Resale Sch. VI.

Deputy Turpin along with FTO Watson LCSO, were advised that Knox County was in pursuit at speeds of 130 MPH on a Gray Hyundai Elantra with a temp tag going towards Loudon County on I-40 West. Prior to the vehicle entering our county, Knox County terminated the pursuit. Lenior City PD advised they saw the vehicle get off exit 81 run the red light and then get back onto I-75

South. We observed the vehicle drive past in the area of the 78-mile marker. The deputies then followed the vehicle to exit 72 where Cpl. Dishner and Deputy Broderick were waiting. The deputies performed a traffic stop on the vehicle on the off-ramp of I-75 South at exit 72. It was occupied by two people; they complied with commands and were detained without incident. Deputies identified the driver to be Jasmine Lansden (offender) and the passenger to be Jermichael Campbell (offender). Upon searching the vehicle due to the odor of marijuana, 28 sealed bags of what is to be believed as marijuana and 5 large clear bags of a green leafy substance were discovered in a black backpack

behind the driver's seat. 4 cell phones were located inside the vehicle, due to the probability the suspects were engaging in resale of narcotics the phones were placed into evidence. Deputies were unable to weigh the narcotics due to the size of the bags. Deputies was advised by dispatch that Mr. Campbell had multiple warrants from Hamilton County. After read-

ing the Miranda warning to both subjects, they both declined to speak with Deputies. Due to neither suspect taking ownership of the narcotics both were placed into custody. We then transported both subjects to the Loudon County Jail without incident. The vehicle was towed by James's wrecker service, all of the above occurred in Loudon County.

Christine Millrainey, 41, Chambers Street Georgia, was charged with, DUI.

Officer Carroll LCPD, responded to the area of the Exxon- 1111 Hwy 321 N in Lenoir City for a Reckless Driver call. Upon arrival, the officer made contact with the vehicle in question which was identified as a dark blue Chevy Traverse GA tag#S-DG2951 in the parking lot of the Exxon on Hwy 321 N. Upon speaking with the driver, the officer observed a strong odor of alcohol emitting from the vehicle, and the female driver to have watery, bloodshot eyes. The female driver was identified as Christine Elizabeth Millrainey. Ms. Millrainey advised that she had a few drinks that morning, but none recently. The officer asked Ms. Millrainey if she would consent to Standardized Field Sobriety

“I have bad hips, so I cant do any balancing tests.” the officer advised Ms. Millrainey he could at least do HGN to ensure she was safe to operate a motor vehicle, to which she consented. During the HGN test, Ms. Millrainey had lack of smooth pursuit, Distinct and Sustained Nystagmus at Maximum Deviation, and Onset Nystagmus prior to the 45 degrees. Ms. Millrainey was placed into custody, and read Implied Consent to which she gave consent for a blood draw. The officer then spoke to the complainant, who stated he followed Ms. Millrainey from the I75/72 exit, all the way to the 81 exit, and noticed her swerving, and failing to maintain her lane of travel. Ms. Millrainey was transported to the ER for a blood draw, and then to the Loudon County jail without any further incident. This did take place within Lenoir City, Loudon County, TN.

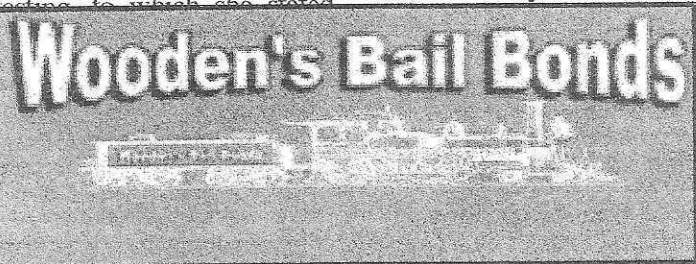

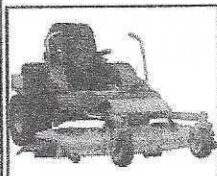

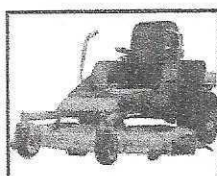

James Ramsey, 53, Industrial Park Drive Lenoir City, was charged with, Man/Sell/Del/Resale Sch. II., and Tampering/Fabricating with Evidence.

Officer Brown, along with his FTO, Officer Eldridge LCPD, were patrolling the area of W Broadway when they observed (James Ramsey) and a female in the area. A Warrant check was performed on both subjects and the jail advised that Ramsey, had an FTA out of Knox Co for his arrest. A traffic stop was initiated on their vehicle (852BKBK) at W Broadway and Central Park. Officers made contact with the subjects and Ramsey was placed in custody at that time. After arriving at the jail, Officers noticed that Ramsey only had one sock on and when asked about it stated "he didn't have time to put the other one on" The jail took custody of Ramsey and offi-

cers performed a search of the back seat of the patrol vehicle and noticed a sock, and small plastic baggie that contained a white powdery substance in the floor board. Ramsey first denied that the drugs were his and stated that officers had put the substance there but finally admitted to trying to dispose of the evidence. After leaving the jail, Officer Miller conducted a TruNarc test on the substance, which was confirmed to be 1.19g of Cocaine. This did occur in Lenoir City, Loudon Co, TN.

Police beat

Shane Thompson, 45, Homeless Lenoir City, was charged with, Public Intoxication.

Deputy Frye LCSO, was flagged down at the EZ Stop on Broadway (501 W Broadway) by a female worker who stated that there was an intoxicated male inside who had been stealing alcohol from the cooler. Upon entering the store, the deputy made contact with the

offender, Shane Thompson, sitting at the table. The deputy could smell an alcoholic beverage emitting from his person. The deputy asked Shane what was going on, and he admitted to drinking and stealing the alcohol. Shane continuously apologized for stealing and said he would pay the store back but he did not have a job or any money. The store clerk called management who refused to press charges for Theft, but wanted Shane to be criminally trespassed.

The deputy then went and spoke with Shane who admitted to drinking three drinks, and observed him not being able to sit still and fidgeting. **Shane is a danger to himself**

as well as others due to being homeless and going into public intoxicated. The store had multiple people inside when Shane became angry and loud causing an annoyance. Due to this incident, Shane is being charged with Public Intoxication (TCA 39-17-310). The deputy then placed Shane under arrest and transported him to the Loudon County Detention Facility. This incident did occur in Loudon County, TN.

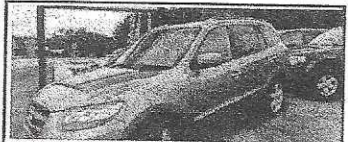
Shane was made aware that he was Criminally Trespassed from the location, and that charges were not pressed for Theft, due to management not wanting to proceed with charges.

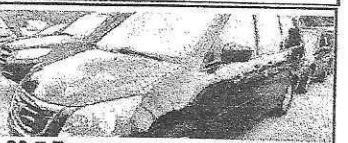

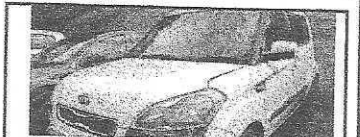

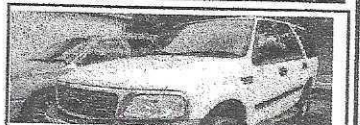

Dustin Thompson, 40, Yellow Cliffs Creek Road Sparta, was charged with, DUI, Violation of Implied Consent, and Driving on Revoked/Suspended License.

Deputy Brockwell LCSO, ran the registration of a blue Ford pickup truck (Florida registration #JP65Q). The registration came back expired. The deputy initiated a traffic stop on said vehicle westbound on Interstate 40 just before the 362 exit. The deputy came in contact with the driver, Dustin Thompson. When the deputy started speaking with Thompson, he noticed that he was sweating a lot and talking very fast. When the deputy asked for his driver's license, he told him that it was revoked and handed the deputy an identification-only card. The deputy ran Thompson through dispatch and confirmed that his driver's license was revoked. The deputy asked Thompson to step out

of the vehicle due to his erratic behavior and to speak with him further. When speaking to him outside of the vehicle, Thompson became more erratic with his movements and could not stand still almost falling in the roadway multiple times. He was also getting more and more sweaty during the conversation with it only being 42 degrees outside. Thompson's behavior, based on the deputy training and experience, resembled someone who was under the influence of a narcotic. While speaking to Thompson, he gave the deputy consent to search the vehicle. While searching the vehicle, there were multiple empty and uncapped syringes in the vehicle along with aluminum foil with residue inside of it. Based on the totality of the totality of the circumstances, Thompson's condition, and state of mind, Standardized Field Sobriety Testing was not performed. The deputy placed Thompson under arrest for driving on a revoked

license and driving under the influence. Thompson's vehicle was released to a licensed driver. Thompson was transported to the Loudon County Detention Facility. While at the Detention Facility, Thompson was read the Implied Consent Advisement form and refused to provide a sample. This did happen in Loudon County, TN without further incident.

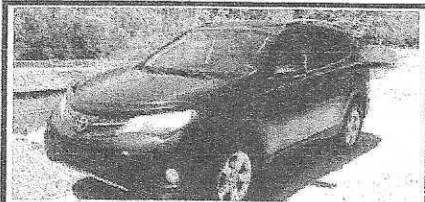

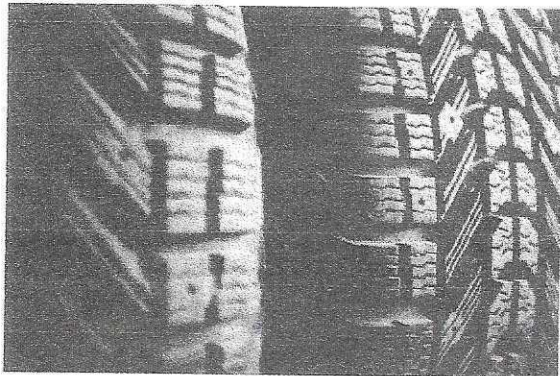
